SERIOUS ACCIDENT.

Patal Result.

Patrick Bourke, fifty, a labourer, was admitted to Barrington's Hospital on Tuesday night in an unconscious state, and suffering from serious injury to the head and other parts of the body, caused, it is stated, by accidentally falling into a vard or cellar. He is in a critical condition, and but faint hopes are entertained of his recovery.

On inquiry at Barrington's Hospital to-day it was ascertained that the patient, who was so seriously injured by falling into a cellar at Arthur's Quay on Tuesday night, was still sinconscious. He is believed to have sustained a fracture of the base of the skull, and was suffering from hemorrhage of the brain. There were no hopes of his recovery, owing to the nature of the impuries the received, and Bourke died at 1.15 this afternoon.

REV. W. NICHOLAS, D.D.

Eminent Methodist Minister Dead.

News has been received at Belfast of the death at Portrush. Co. Antrim, of the Rev' W. Nicholas, D.D. a leading minister of the Irish Methodist Church. The deceased, who was a native of Co. Wexford, was over 70 years of age. He was one of the principal speakers at the recent demonstration of Methodists in Belfast against Home Rule. He ministered to the Wesleyan Church in Limerick and Cork in the course of his itinerary through Ireland, and the news of his death will cause unfeigned regret. He held many positions of honour, and was regarded as a scholarly and eloquent prescher. The offices he held included that of President and Theological Professor in the Methodist College, Belfast; member of the benate of the Royal University of Ireland; "Vice President of the Methodist Conference, 1894-5 and 1902-4 was elected several times as representative to the British Conference, and was deputed to represent Irish Methodism at the Ecumenical Conference in Washington, U.S.A., to the London Anniversary, 1886 ; the Evangelical Alliance, Copenhagen, 1884; Florence, 18911; and Plymouth, 1892. valler was for many years secretary and then treasurer of the Education Department. Deceased was a member of the London Council of the Evangelical Alliance, and took an active part in the Home Rule controversy. In 1893 he was appointed to the Fernley Lectureship.
