#### IMPORTANT INSURANCE CASE.

Michael Moran, labourer, processed the Irish Mutual Insurance Society to recover £20 10s, alleged to be due by the defendants on the life of applicants brothe, Joseph Moran, who became deceased on the 18th October last. The defendant Company resisted the claim on the grounds of misrepresentation and that applicant had no insurable interest in the person, under the statute of George III. Evidence having been given.
