

from the agreement, but the agreement was made on the 27th, the proportion payable in respect of the same. The questions now for the Court are—(1) Did the order of the Land Commission of 9th, 1910, preclude plaintiff from recovering? (2) Did the agreement for purchase of 25th, 1911, preclude the plaintiff from recovering the charge claimed by him? as the plaintiff precluded from recovering reason of any of the above facts? If all questions be answered in the negative, the claim to be affirmed with costs. If any of the questions be answered in the affirmative, the claim to be affirmed with costs.

H. D. Conner, K.C., and Mr. Robert Conner (instructed by Mr. Dodd) appeared for the plaintiff.

Patrick Lynch, K.C., and Mr. Patrick Lynch (instructed by Mr. T. H. Kenny) appeared for the defendant.

The Lord Chief Baron, in delivering judgment, held that he did not regard the claim as a rent, but as a payment in the nature of a rent. So far as the arrears of this were concerned, the defendant was not liable. His lordship thought that the "vendor" in the agreement was interchangeable with the well-known term landlord, and for all practical purposes it is the same. If the agreement were not carried out the parties reverted to their former position. The Court, therefore, regarding the application as premature, dismissed the claim of the Knight of Glin. The defendant should be allowed his costs of the present argument. The other members of the Court concurred in the judgment.

CHARGE OF RECEIVING BICYCLES.

Parents Returned for Trial.

A charge of receiving bicycles, knowing them to have been come by honestly, was investigated at Patrickswell Petty Sessions on Tuesday night. The charge arose out of the stealing of ten ladies' and gentlemen's bicycles, for which offence Thomas Byrnes, a youth of twelve, was sent to Millinstown Reformatory for seven years by the Court on the same day, as reported in our last issue.

District Inspector Meredith, Adara, prosecuted, and Mr. H. O'B. Moran, solicitor, represented the defendants, with the exception of the Byrnes's, the parents of the boy.

The investigation occupied six hours, and the burden of the evidence was that in disposing of the property Thomas Byrnes reported that he received it from a lady, with a view to the money being utilised for a charitable purpose.

After a long consultation, the magistrates by a majority refused information in the case against John Michael, Margaret, and Patrick Quirke, and Mary Quin, and John Mullane, and returned Henry and Mary Byrnes for trial on nominal bail.
