

CITY PETTY SESSIONS.

The adjudicating Magistrates at the City Petty Sessions yesterday were Messrs. P. J. Kelly, R. J. O'Grady, and J. Quin.

CRUELTY TO A HORSE.

Patrick Delany, Castleconnell, was prosecuted for allowing a horse to be worked while in an unfit condition, and Patrick McCarthy, for working the animal.

Mr. M. Linnane, Inspector to the Society for the Prevention of Cruelty to Animals, stated that the animal had five sores on the breast.

A fine of 2s 6d was imposed on the owner of the horse, and 10s on the driver.

Patrick McCarthy, Castleconnell, was fined 10s. and 1s. 6d. costs for working a horse in the city on the 25th February, while suffering from sores under the harness.

STREET OBSTRUCTION.

A number of juveniles from the Thomondgate district were charged with obstructing the thoroughfare by hurling and playing football.

A fine of 1s and costs was imposed in each case.
