## DROWNING FATALITY.

A man named Martin Sweeny, 30, married, and residing at Market Alley, was missing from his house since the 20th of last month, and his disappearance was duly notified to the authorities. On Thursday night a search party found the body of the missing man floating in the basin at the west side of Wellesley Bridge and had it removed Morgue, an inquest being evening before the City Coroner. held last Mr. J. F. Barry, J P. Evidence was given by a brother of the deceased that Sweeney was ide for two months; that he left the house on the night of the 20th ult., in his usual good health, without saying where he was going; the deceased was a tin-smith. The medical evidence was that death resulted from drowning, Dr. Graham stating that he found no marks of violence on the body. The jury returned an open verdiet, adding a strongly worded resolution as a rider with regard to the questionable condition in which the morgue is kept by the Corporation.

one other paragraph, which we should like read from the report of the Commission on this scheme. It occurred at page 51 paragraph 235. It was 'we have already pointed out the essential difference between the conditions prevailing in Ireland with those in England. We have shown how sparsely the districts are populated, how few are the industrial centres and how little traffic there is for conveyance between the inland districts and seaports. We have also shown that there is a great absence of minerals and of heavy traffic carried. We are, however, confronted by the fact that no definite and elaborated proposition was placed before us in evidence for new works of improvement on a considerable scale on any of the main lines of navigation. If, indeed, any such schemes had been proposed, we should have been compelled to report that the possibility of a greatly increased traffic in inland waterways in Ireland, even if they are improved, is so remote that there is not sufficient justification at the present time for any large new works involving great ex-penditure, such as those the commencement of which the Commission have suggested in their report on England, Wales, and Scotland." So, continued counsel, we have it here that the official conclusion which that Commission have come to was that there was no sufficient justification for them to report on an expenditure on new works on the inland waterways of this country. As far as Messes McGuire's were concerned, they had got a claim, and some other gentlemen had got claims. They could be met by arbitration, but a suggestion had been made that the proposals put forward in the Harbour Commissioners Bill had been put forward by a clique—by people who owned property below the bridge, with the object of improving their own, trade to the detriment of people owning property above the bridge. He could not too strongly condemn or deny that proposition on hehalf of the promoters of the Bill. Everybody that knew the bridge knew that suggestions for replacing it were before the Harbour Board, and that they were going to deal with it. If the members of the Corporation did
