TWO IMPORTANT MEETINGS

INTERESTING PROCEEDINGS

(FROM OUR CORRESPONDENT.)

A meeting was held in the Castle Hall, Kilmallock, for the purpose of establishing a corps of the Irish Volunteers. Mr. L. The Chairman returned thanks for asking him to preside. He explained the objects of the movement and said he was at the inaugural meeting held in Dublin and would give them all the assistance in his power.

Mr. N. Gaffney in an effective speech dealt with different aspects of the movement and said for the purpose of instruction it would be necessary to have the services of an ex-military

Mr. John O'Connor-Any man that sold his country for a shilling, leave him out.

Mr. W. O'Grady-No, no.

Mr. Gaffney-As you raised the question I'll answer it. I never knew an Irishman to go into the British army but when he could not get any other employment and it never made him a worse man (hear, hear). The Irish soldiers were as National as themselves.

Chairman-Hear, hear.

Mr Gaffney-and I am well aware of it. I am sorry the question was raised. Continuing. he said he was well aware that in the Fenian times redcoated men were the best Fenians in Ireland, and referred to Colour-Sergeant M. Carthy, Effin, and John Flood, Kilmallock. A man never sold-himself for the shilling, and if an Irishman joined the British Army he had no Irish Army to list in. Some men might laugh at the Volunteer movement but it was a movement that meant to make Ireland a

Chairman-Hear, hear.

Mr. James Ryan proposed, and Mr. N. Gaffney seconded—" That a regiment of the Irish National Volunteers be formed in Kilmallock, and that it be called the 67th Regiment, Kilmallock Volunteers (Sarsfield's Own).

The Chairman said with regard to the observation as to military men, one of the first of the rules was to secure the services of a competent instructor and utilise all the ex-military men possible. He was understood to say that the gentleman who drafted it was one of the best Nationalists in Ireland. They were to exclude obody, and everyone was clearly to understand that the aims of the Volunteers were to secure and maintain the rights common to the whole of the people.

Mr. Joseph Gaffney supported the resolution, and explained the objects of the movement in a lucid and forcible address, in the course of which he referred to the objection raised to ex-soldiers, and mentioned the number of soldiers in the British army who had joined

the Fenian Brotherhood. Mr. O'Grady said he was sorry that the amount of interest in the movement shown by the young people was not up to their expectations. There was a good gathering of the Gaels, but there should be a lot more present. There had been great musters of people elsewhere, but the meeting that night was not as

West Limerick Nun's Death

Our Abbeyfeale correspondent writes :- In her 48th year. after only a few days' illness, the death of Sister Mary Berchmans (Barrett), which is very sincerely regretted, occurred at the Convent of Mercy, The Rosary, Abbeyfeale. Her death has closed a truly saintly career-a life full of exemplary exertion in the holy cause of charity. Sister Ber-mans was daughter of the late Mr. Thomas Barrett, of Athea, and had spent many years of her spiritual life at the Ballingarry Branch of the Convent prior to returning to Abbeyfeale two years ago. She never tine of ministering to the sick poor, and amongst the poor and destitute her charitable efforts never ceased. It was certainly the promptings of a saintly heart that delighted in gathering round the doors of "The Rosary" the outcasts-the rejected homeless itinerants of the road-and so often succeeded in brightening the milestones of many of those unfortunate despairing wanderers. The depth of such striking acts of charity was an edification, even to the good Sisters around her.
