Again, I am badly off for six or eight good milch cows, which I could have got easily at the auctions last week, but could not buy them when I would not be allowed to take them home. I may chance to get a few in Clare later on, but I must have the ready money, whereas if I got them at the auctions I need not pay for them for two or three months, and their milk would have made a good share of the purchase money by that time. I know that several people are worse off than I am, for they are struggling on with a few cows and cannot get money to buy the few more they want in the open fair, while they would get time from the auctioneer. I think our members of Parliament should take action in the matter, as it is a serious loss to many a poor man. The grass is good and the year is going, and they have not their usual number of stock. Hoping you will be good enough to publish this in next issue of your influential journal, as it might be the means of doing some good to many people by drawing attention to our grievances. RETURNED FOR TRIAL

CITY MEN CHARGED WITH ASSAULT AND LARCENY

CASES AT SPECIAL COURT TO-DAY

At a special court held at the City Court-house to-day by Mr. P. J. Kelly, R.M., a man named Slattery who was charged with assaulting a man named O'Halloran, on the 7th Nov. last, was returned for trial, on bail to the next Quarter Sessions.

At the same court, Christopher Rice was charged with the larceny of a sum of money from Miss Hanna, International Hotel, O'Connell-street. Depositions having been taken the accused was returned for trial to the Quarter Sessions, bail being allowed. Mr. James H. Moran, solicitor, appeared for the defendants.

Sequel to Petty Sessions Case

APPLICATION IN KING'S BENCH

DECISION OF COURT TO-DAY

In the King's Bench Division, Dublin, to-day, Mr. Ernest J. Phelps (who was instructed by Messrs James H. Moran, solicitor), applied for an order of certiorari for a conditional order to quash a conviction made by the magistrates at the Limerick City Petty Sessions on Friday in two cases, one against a man named Patrick Halvey and the other against a man named Cornelius Sexton, by which they were sentenced to a month's imprisonment with hard labour and bound to the peace for twelve months of £10 and two sureties of £5 each for an alleged assault on a man named O'Brien. Counsel moved on the affidavit of Mr. H. O'B. Moran, solicitor, and stated the grounds on which the application was made were that the order was bad on its face; was bad in point of law and that it was in excess of and without jurisdiction.

The Court granted the conditional order sought for.

The drafting of rules, etc., was referred to the Executive Committee, and after some important business being transacted a vote of thanks was passed to his Worship the Mayor for granting the use of the Council Chamber, and the meeting adjourned.

Dead in a Field

EAST LIMERICK MAN'S SAD END

A young man named James Brosnan was found dead on Tuesday morning in a field at Ballinacurra, Hospital, County Limerick. In the evening an inquest was held by Coroner P. J. Cleary, M.D. The evidence went to show that Brosnan had been at work on the previous day, and was proceeding homewards by the field when he succumbed, death being due to natural causes.

Conflict With Police

SEVERAL PERSONS INJURED

A Central News wire received from Lyons says:—Two thousand workmen employed on the Exhibition buildings suspended work following a rioting conflict with the police. Several persons were injured by thrusts of police swords.

Death of Mr. Morgan Fitzmaurice

The death occurred on yesterday at his residence, Harbour View, of Mr. Morgan Fitzmaurice, late Harbour Master of the port of Limerick. For some years back Mr. Fitzmaurice had been in indifferent health, and his death was not unexpected. Early in life Mr. Fitzmaurice took to a sea-faring life, from which he passed in 1871 to the service of the Harbour Board. He held the position of Harbour Master until 1902, when he retired on a well-earned pension. Much sympathy is expressed with his relatives in their sad bereavement.
