The Workers' Grievances

STRIKES NO REMEDY

Addressing a meeting of the Irish Dockers and Workers' Union in the Hall, Denmarkstreet, Dublin, on Friday night, Very Rev. Father O'Kane, O.P., said the workers must not imagine, as Socialists sometimes told them, that labour and capital were opposing forces, inimical and absolutely hostile one to the other. On the contrary, they were forces necessary one to the other, and should never be inimical. Trade Unionism must be built upon principles of justice; the working contract must be observed, and there must be honest remuneration for the time worked. Father thought the working man O'Kane badly treated under existing conditions. The danger existed that enterprising men would get hold of the workingman, inflame his passions, and make him all kinds of specious promises, exploit him for all he was worth for their own ends, and lead him into all kinds of trouble, Facts did not prove that the strike was always an effective weapon. It was not a remedy, generally speaking, in any sense. It was a drastic remedy to be applied only under exceptional circumstances. The workers would get more by bargaining than by strikes.

Father M'Inerney, O.P., said men like Larkin would not have 100 men to follow him in Australia, where the workingmen had not gone in for Socialism but for thoroughly sensible

Irish Labourers Bill

TEXT OF THE MEASURE

The following is the text of the Bill, presented by Mr. Birrell and supported by Mr. T. W. Russell, to amend the law relating to labourers in Ireland:—

Be it enacted by the King's most Excellent Majesty, by and with the advice and consent of the Lords Spiritual and Temporal, and Commons, in this present Parliament assembled, and by the authority of the same, as

follows :-

1—(1) The limit on the amount of the advances that may be made by the Land Commission under section sixteen of the Labourers (Ireland) Act, 1906, shall be six million two hundred and fifty thousand pounds, instead of five million two hundred and fifty thousand pounds, and accordingly that section, as amended by section two of the Labourers (Ireland) Act, 1911, shall have effect, with the substitution of the sum first mentioned in this sub-section for the sum, secondly mentioned in

this sub-section.

(2) The limit on the amount of the payment that may in any year be charged on the Ireland Development Grant for the purposes of section sixteen of the Labourers (Ireland) Act, 1906, or, in the event of that grant being insufficient, be defrayed out of moneys provided by Parliament, shall be forty-one thousand pounds, instead of thirty-four thousand five hundred pounds, and accordingly section fourteen of the Labourers (Ireland) Act, 1906, and section eleven of the Irish Land Act, 1909, as amended by section three of the Labourers (Ireland) Act, 1911, shall have effect, with the substitution of the sum first mentioned in this sub-section.

2. This Act may be cited as the Labourers (Ireland) Act, 1914, and shall be construed as one with the Labourers (Ireland) Acts, 1883 to 1911, and may be cited with those Acts.

Distinguished Clare Lady

was born on the 8th February, 1843, for the purpose of obtaining an old age pension. Mr. F. F. Cullinan, C.S., prosecuted, and the defendant was not professionally represented.

Mr. Cullinan said that the defendant applied for an old age pension on the 29th March, 1913, and the claim, which was passed by the local committee, was disallowed on appeal. On the 8th September she again applied on the strength of a certificate purporting to be signed by Canon Mollinaux, Ballybunnion, stating that she was born on the 8th February, 1843. On inquiries it was found that this was untrue, and hence those proceedings were instituted.

Messrs. Goodwin Fitton, Postmaster at Quilty, and John Stack, Postmaster at Spanish Point, gave evidence of the defendant coming to them and making application for a pension.

Mr. J. T. Davis, local Pension Officer, deposed he received the certificate produced as to this woman's age; he had the case investigated and it was found to be incorrect.

John Collins, Parish Clerk at Ballybunion, deposed that the defendant's name was not in the registry of the parishes of Ballybunion and Ballydonohoe; the certificate produced was not in Canon Mollinaux's writing.

The defendant said she was registered in the parish of Doon and that was where she was born; she got this certificate from her niece.

Mr. W. D. Edgar, Pension Officer, Listowel, deposed he searched the parish registry of Doon and found the name of the defendant there for 3rd June, 1849.

The Chairman said they had decided to convict, and inquired what would be the result of a conviction as regards her obtaining a pension in the future should she become the age.

Mr. Cullinan—If she were sent to jail it would disqualify her for two years, but if a fine is imposed it won't affect her in any way. Continuing, Mr. Cullinan asked that a reasonable fine be imposed. This was an expensive prosecution, and if a fairly reasonable fine was not imposed it would have no deterrent effect on such people as the defendant.

The Chairman said the defendant would be

fined 10s. 6d., with 4s. 6d. costs.
