of State for War. The King has approved the appointment of Lord Kitchener as his successor. Lord Kitchener undertakes the duties of the office for the time being, in view of the emergency created by the war, and his post in Egypt will be kept open." Born at Crotter House, Ballylongford, Co. Kerry, on June 24, 1850, Horatio Herbert Kitchener Is a son of the late Lieutenant-Colonel H. H. Kitchener, of Cossington, Leicestershire, From his school days he cherished an ardent desire to enter his father's profession, and at the age of 18 was sent to the Royal Military College, Woolwich. In 1871 he joined the Royal Engineers, and the first ten years of his service were spent in civil employment in Palestine and Cypris. He then volunteered for Egypt, at the time that Sir Evelyn Wood, as Sirdar, was building up an army in that country. Upon his return home after the catastrophe at Khartum he was promoted from the rank of Captain, which he had attained in 1883, to that of Lieutenant-Colonel. In 1888 he became Adjutant-General of the Egyptian Army with Brevet rank as Colonel, and in April, 1892, he was appointed Sirdar, in succession to Francis, afterwards Lord Grenfell. For his subsequent achievements in the Sudan, the Sirdar was raised to the Peerage with the title of Baron Kitchener of Khartum, receiving also the G.C.B. He has since received many other marks of distinction, Mr. Balfour, in proposing a Parliamentary grant of £30,000 to Lord Kitchener, described him as "the organiser of victory, whose foresight was never at fault," while Sir H. Campbell-Bannerman characterised the complete success he had achieved under the conditions as constituting one of the most brilliant pages in the history of British arms." Lord Kitchener's services in South Africa with Lord Roberts, his military reforms in India, and his occupancy of the position of Commander-in-Chief and High Commissioner in the Mediterranean, are still in the public mind. He has been described as a hard and accurate thinker, of undaunted courage, perfect simplicity, and absolute sincerity of purpose.
