ascendancy" over the Kaiser's terrible Uhlands—
how much do they not owe to the racing saddle
and the hunting field? Most of our cavalry
officers—and many of their men—have picked up
the essential elements of their calling behind one
or other of the 212 packs of foxhounds in Great
Britain and Ireland. Fifty-four Masters of Hounds
are serving with the colours, and many hundreds
of hunt servants have exchanged the similitude
for the stern realities of war. The War Office
has obtained at least 10,000 horses from the
hunts, and the hunter makes the best possible type
of troop horse. To stop hunting and racing at a
time when good cavalry are one of the vital
necessities of the State would be, indeed, an act
of folly. Their continuance is essential because
they give employment to thousands of honest
citizens, and help to secure the liberties of every
citizen by furnishing the nation's Army with
sound horses and gallant men.
