### City Candidate Chairman.

### Windsor Meeting.

A verdict of accidental death was returned at an inquest at Gorleston last night on Mrs Henry Lawrence Cubitt, aged 50, wife of a retired bank manager, who was killed yesterday while assisting a neighbour, Dr David Walter, to excavate a bomb-proof shelter in his garden. Some of the woodwork collapsed and deceased was pinned against the side of the trench. She was dead when released. The doctor who conducted the post-mortem said death was due heart failure from shock.

### DEATH OF MR. EDWARD RYAN.

We regret to announce the death, which occurred last night at his residence, 28 Charlotte Quay, of Mr Edward Ryan, the oldest surviving member of the Typographical Association in this city. He had been for over forty years a valued employee of Messrs G McKern & Sons, and some years ago retired from active work for well-earned rest. He was a man highly respected, not only by his employers and fellow members of the craft, with which his name for a wide span of years was so honourably associated, but by numerous friends in private life, to whom his frank and genial manner endeared him, and now that he has passed away, one of the few remaining links with an almost passed generation has been severed, and removes from us an old and esteemed citizen. ### BELIEF ACT.

The Local Government Board wrote drawing attention to the provision of the Local Authorities (Disqualification Relief) Act, 1914, received the Royal Assent on the 27th Nov last. The effect of the new Act was during the present war to extend the relief from disqualification for office to all members of the naval, military forces employed on any naval or military service. No person shall not by reason of his absence on that service be disqualified to vacate his office as a member of any County Borough, or District Council or Board of Guardians, or incur any fine or other liability. ### BALLINGARRY GRAVEYARD.
