## LORD LIEUTENANT

### Presented with the Freedom of Cork.

The Marquis of Aberdeen was on Wednesday presented with the Freedom of the City of Cork. The ceremony took place in the City Hall in the presence of members of the Corporation and of the general public. Escorted by a troop of the Irish Horse, Lord and Lady Aberdeen, on their arrival at the platform where the presentation was made, were received by the Lord Mayor and the City High Sheriff. After signing the Roll of Freemen, Lord Aberdeen thanked the Lord Mayor and the Corporation for the honour done to him. Later in the afternoon His Excellency was presented with an address by the Cork Harbour Commissioners and the Governing Body of University College.

## GALWAY AS A NAVAL BASE.

With regard to a rumour that Galway is likely to be made a naval base, it is pointed out that it is now a base for patrol duty, and it is added that it is likely five or six heavily armoured vessels will be stationed in or near Galway Bay within the next few weeks, while it is also suggested that the eastern portion of the bay may soon be utilised for ship-repairing purposes.

## FATAL SHOOTING ACCIDENT

Waterford, Monday.

An inquest was held this afternoon by the Deputy Coroner (Dr. G. L. Mackesy, J.P.) and a jury, of which Mr. John Boye, Michael Street, was foreman, on the body of William Hartery, aged 61, who died in the County and City Infirmary on Sunday, from blood poisoning as the result of a bullet wound accidentally received whilst journeying to Limerick with the Waterford Volunteer Corps, of which he was a member, on Sunday, 20th December last. A man named John Lanigan is on bail awaiting trial in connection with the occurrence.

## VALUE OF LAND NEAR ENNIS.

At the Courthouse Ennis, on Friday, Mr. M. McMahon, Auctioneer, Ennis, disposed of the grazing lands at Drombiggle and Cahercalla, in the possession of Mr. W. F. Crowe, J.P. It was decided to reply stating that in the opinion of the Executive there was no necessity for the miners working six days, or the suspension of the Eight Hours Act.

## MOTOR MISHAP IN THE CITY.

An extraordinary accident occurred in Le Hartstonge street some time after 11 o'clock Monday morning. A large motor lorry belong to Messrs. J. Banpatyne and Sons was being driven from the direction of the docks, when steering gear went wrong, and the vehicle ran into the rails of the area of No. 21 Hartstonge street. In the impact the iron rail was torn and the stonework displaced. The lorry was empty at the time, and the singular thing is that it escaped falling into the area. Had this taken place, nothing could have averted a serious accident to the driver, who, fortunately, was hurt. Another gratifying feature in connection with the mishap was that the sidewalk was clear of pedestrians at the time.

## ROYAL IRISH CONSTABULARY.
