## FUNERAL OF MR MARTIN LEAHY, J.P.

The remains of the late Mr Martin Leahy, J.P., whose death occurred on Thursday morning, after a somewhat protracted illness, were interred this morning in Mount St. Laurence Cemetery. At 8 o'clock last evening the coffin was removed from 17 Ascot Terrace to St. Michael's R.C. Church, where service was held for the dead this morning. The remains were taken out at 11 o'clock, and the funeral, which was of very large proportions, left for the last resting-place. In the cortege there were representatives of the Corporation, Harbour Board, Poor Law Board, and other interests, who were present to pay a final tribute of respect to the memory of a respected and valued citizen.
