OLD AGE PENSION ACT.

Prosecution At Foynes.

At the Foynes Petty Sessions on Thursday, Mrs Annie Naughton, Deelish, Shanagolden, was charged under Section 9 (1) of the Old Age Pension Act, 1908, with making a false statement with a view to obtaining an old age pension.

Mr J S Gaffney, Crown Solicitor, prosecuted on behalf of the Customs and Excise Authorities; and Mr H O'B Moran, solr, defended.

Mr J Matthew O'Dwyer, Pension Officer, and Mr O'Keefe Lynch, of the Munster and Leinster Bank, Rathkeale, were examined by Mr Gaffney.

Mr O'Dwyer deposed to defendant making a statement to him that neither she nor her husband had any money in bank, and Mr O'Keefe Lynch stated there was a deposit receipt in the Munster and Leinster Bank for £200 in the joint names of the defendant (Mrs Annie Naughton) and her husband.

Both witnesses were closely cross-examined by Moran on behalf of the defendant.

The Court after deliberation for some time convicted the accused, and fined her 10s and 5s expenses.
