### THE LATE REV. G. L. HARKNES

There passed away on January 14th at the age of 91 years a gentleman who was closely con- nected with the Co. Limerick. The Rev George Law Harkness, of Forest Sea, Sway, Hants, was the last surviving son of the Rev Robert Hark- ness, of Athea and Garryfine, Co Limerick. He was for many years Rector of Shaftesbury, Dorset, and was from 1863 to 1875 trustee of the family estates in the County Limerick, and it was during his time that planting and other improvements were done which have helped to make Athea one of the prettiest villages in the County. He was one of the five brothers who in their day were noted athletes. Two of them rowed in the Cambridge crew in 1845, one "kept the field" at Eaton, another "kept the wall," and a third "kept the field" again. Mr Harkness is succeeded by his son, Colonel Harry D'Alton Harkness, C.B, who is at present commanding one of the service battalions of the Cheshire Regi- ment.

### TOURIST DEVELOPMENT PROPERTY.

The liquidator further asked that he should be declared entitled to a fee of 5 per cent on the sales carried out, in full discharge of his re- muneratation. Counsel said everything had been paid off except the debentures, and the hotel and the garage were now the only assets undis-
