FUNERAL OF MRS CUNNINGHAM.

The demise of Mrs Cunningham, wife of Mr
John Cunningham, Bon View, North Strand,
which took place at her residence on Monday, has
evoked feelings of deep regret amongst a wide
circle of friends in City and County. The deceased
lady who came of an old Limerick family had been
ailing for some weeks past. She was very highly
esteemed for her kindly and charitable disposition,
and there is widespread sympathy with her
husband in his keen sorrow. The funeral took
place on Wednesday from St Munchin's Parochial
Church whither the remains had been removed
on Tuesday evening. The cortege was of very
large proportions, embracing representatives of all
sections of the community, and it afforded ample
evidence of respect and sympathy. The monster
drapery house and various other establishments
had their blinds drawn while the funeral passed.
Numerous telegrams and letters of sympathy have
been received from London, Liverpool, Dublin,
and Belfast.

Munchin's at 10.30 on Wednesday. The celebrant
