· Price Lists Asked For

The Committee's attention has been called to the fact that despite their request in a previous report there are a number of shopk-sepers not displaying price lists of goods on their premises, and the Committee respectfully suggest that householders should deal only with firms and shopowners who display such lists.

The prices of milk, bacon, and bread were dis-

ussed.

The Committee decided that Is 4d per gallon was a reasonable price for milk supplied in the city.

The Secretary reported that the price lists promised at the last meeting by the local butchers had not yet come to hand, and the members expressed themselves disappointed in the matter.

The death took place in a Dublin hospital on Thursday of Mr John Dunne, Glin, at an early age. The deceased represented the division of Glin in the Limerick County Council, and was a prominent member of the Sinn Fein organisation. The remains arrived at Foynes on Friday, and the funeral, which was attended by a large number of Volunteers, took place next day for interment in the family burial place.

(5) That the committee dissolve annually and that each of the undermentioned appoint their quota of members annually to same, date of election to be decided by the committee. (6) That the committee be constituted as follows:-Two members of the Kilmalleck District Council, two members of the Fermers' Union (one Kilmallock branch and one Ballingaddy branch), two members of the Kilmallock Sinn Club, two members of the Ballingaddy Sinn Frin Club, two members representing traders, town of Kilmallock; two members of Kilmallock branch I T and G W Union, the chairman of the Kilmallock District Council, and Dr Michael Sneedy.
