The League says that several million pounds will be spent throughout the country in preparation for the Christmas, and if Irish communities. families, and individuals stock their pantries with Irish goods, as far as possible, and present their friends at home and abroad with Christmas gifts and greeting cards of Irish material, the millions will remain in Ireland, and the goods will be quickly replaced by Irish labour. "Our present precarious condition, (says the League), firmly demands of us to use our better judgments at the Christmas markets of this year. It is well that some realise the danger. Upwards of 50,000 people throughout the country have already pledged themselves under the League, to insist on being supplied with Irish goods, whenever possible, and to support our industries in every way. Their attitude seems to be a verg reasonable one. They are not sworn to boycott any particular class of goods. They are not attacking the industries of any particular country. They recognise that our population has increased, that our industries have diminished, and that the cost of living still remains very high. Who then can accuse them of provoking the retaliation of any country or Government, if under such orcumstances they deem it their duty to defend their own industries, and thereby relieve the situation in Ireland?"

#### TRAMCAR OVERTURNS.

Seven Persons Injured.

By the overturning of a tramear at Handsworth, Birmingham, on Sunday morning, seven people were injured, though none of them very sericusly. The car was proceeding to Birmingham, and, when nearly opposite the police station, it left the rails, and taking an oblique course, continued running about twenty yards. Then the front wheels struck a kerbstone, and the car capsized. There were five passengers, and they were thrown from their seats and cut by broken glass. One of them, a girl, was detained in hospital suffering from shock and minor injuries. The others were able to proceed home, but the driver and conductor were detained.

### WORKER'S SUDDEN DEATH.

Mr J S McNelce, City Coroner, held an inquest on Saturday evening in Barrington's Hospital on the body of Lawrence Brett, 48 years of age and married, who died suddenly on Friday night while at work in a city flour mill.

Sergeant O'Donnell represented the Civic Guard, and evidence of identification having been given, the medical evidence showed that deceased suffered from heart affection, which was the

cause of death.

The jury returned a verdict in accordance with the medical testimony, and recommended the widow and children to the kind consideration of the employers of the deceased.
