return to normal life, while in process, must, while it finds new and resumed avenues of employment, also throw thousands on the labour market as they are released from exceptional and temporary occupations." The problem of unemployment that still remains for solution and, possibly, as our contemporary auggests, it will be to some extent relieved by temporary expedients that will provide reproductive employment. The gradual but steady return to normal conditions in the country is a cheery element, and one that gives hope of brighter days to come. And when these do come, industries will develop and the prospects of employment will accordingly be greater. We must, then, all do our part to hasten that ideal, to work with a will for the good of the country and leave nothing undone that will tend to bring work to all and with it prosperity for trade and commerce in this land.
