GERMAN PRESIDENT DEAD

Berlin, Saturday. President Ebert is dead. The death occurred at 10.15 a.m. to-day.

. This morning's bulletin, in which the doctors stated that they regarded the Pr sidence condition as hopeless, came as a great shock, partionlarly in view of last night's bulletin, which said that the improvement in Herr Ebert's condition was continuing.

The sudden turn for the worse was due to the fact that at 5 o'clock this morning the peritonitis became worse, and the patient's vitality and resistance became considerably weaker.

he President died without regaining consolouaness. His wife and children and Dr Melsener, the Secretary of State, were at his bedside.

The majority of Germans will mourn a man of upright character, who by his dignity and tact during the six years he occupied the highest position in the State still further enhanced the prestige he had always enjoyed.

Born in 1871 at Heildelberg, the son of a shoemaker in humble circumstances, Herr Ebert attended the Board School, and became an apprentice to a saddler. He soon abandoned his trade, however, and took an active part in the social-democratic movement, with the result that in 1912 he was elected to the Reichstag. 1913 he became Chairman of the Social-Democratic Party, and in 1916 the leader of the Party in the Reichstag.

EThe part which he played during the final stages of the war, and after the revolution, is historical. His enemies, of course, described him as a traitor, and held him responsible for the collipse of Germany. He became Chancellor after the revolution, then Chairman of the People's Commissioners, and finally, in February, 1919; he was sleeted President of the German Republic.

DROWNED IN THE DEEL.

The Inquest.

The dead body of a young man named Thomas Dowling, of Cullinage, Newcastle West, was found in the River Deel on Sunday afternoon. Deceased had been missing for a week. He was a very popular young man. He was an ex member of the American Army, and fought throughout the Great War. He was going home about 10 p.m. from Newcastle West, and it is surmised that in the darkness he missed his footing on a plank over a stresm which he had to cross on his way home, and fell into the little river, which was then il oded, being conveyed thence to the Deel, where the body was found two miles away. An inquest was held on Monday morning by Mr

Coroner Cussen and a jury, of which Mr J Monahan was foreman.

Rvidence of identification having been given. Thomas Kelisher, of Cultinagh, deposed that on the night of the 22nd February last he saw Thomas Dowling, the deceased, about 10 p.m. The deceased called to witness's house on his way home to borrow a flush lamp. Witness gave him the light and went outside the door with him: He went away home and took the lamp with him, Witness did not see him alive after that, but saw his body on Sunday and again that day, and the body was that of Thomas Dowling.

Michael Quinn. of Maiden street, Newcastla West, stated he was walking along the bank of the river Deel, about 12 L'clock noon ca Sunday, lst March, and at the Kilready side of the river he noticed something white, resembling a body, in the bed of the river. The body was face downwards, part covered with blothes and part After meein body he went for John Reldy, of Kilready, the nearest inhabitant to where the He came with him bod v WAP. the river and brought a drag, which failed to reach the body. John Reidy then left to report the fluding of the body to the Guards at New. castle Wis. Witness remained on the bent of the Deel until the Guards arrived. He saw the deceased's body being lifted up by Guard Carey and brought to the bank, where he identified it as

the body of Thomas Dowling

West, stated that the body was that of a w li nourished man of about 46 years of age. There was a out on the upper part of the nose, and two large wounds in the skull which, in his o inion, were saused after death There were no bruises or marks of violence on the body. In his opinion the cause of death was asphyx'a, due to drowning

The jury returned the following verdict :-"That Thomas Dowling came by his death, so far as can be determined from the evidence, by being accidentally drowned, but cannot state where he got into the Biver Deel, or how long he was in the water, but he would he six days there."

The Coroner and the jury supressed sympathy with the widow as d relatives of the deceased.
