## ANNUAL REPORT.

The ninety-third annual report of the County Limerick Protestant Orphan Society shows that, though the Society is rapidly approaching its Centenary, yet, it is still as vigorous and energetic as ever in the work of relieving those who, through no fault of their own, have had to seek the assistance of the Society.

During the past year 8 children were removed from our care; one, we regret to say, by death, two were placed in situations, two were taken by their mother, as they were over age, and the mother was able to provide for them, one left Limerick, one was admitted to the Masonic School in Dublin, and, in another case the mother, having married again, was in a position to support her child without our aid.

Two children were admitted during the year, and the number under our charge in February, 1926, was 40. Four of these are serving their apprenticeships to different

One of our orphan girls had to be sent to the Stewart Institution in Dublin, and we hereby tender our sincere thanks to all the subscribers to that institution who gave their votes on behalf of this girl. Society is partly responsible for her support, but the County Limerick Board of Health have also undertaken to pay a certain amount per annum.

In looking back through the old reports it is interesting to note that in the early years of the Society, before the building of the Orphan Hall, the annual meetings were held in the Primitive Wesleyan Chapel in Bedford Row; then in the Philosophical Society's house in Glentworth-street, and in other years in the Music Hall, Henry-street, the Theatre of Arts, Henry-street, and for several years in the old Theatre Royal. All these places have either ceased to exist or else have changed their characters entirely, but the Orphan Society has continued on its course true to the original purpose of its founders.

Our accounts show that there has been a slight improvement in the state of our finances.

We began the year 1925 with a debit balance of £1,275 9s 9d, and after payment of all accounts due to date, we closed the year with a debit of £1,089 7s 1d.

The expenses for 1925, excluding the debit from 1924, amounted to £922 12s 2d, and the receipts amounted to £1,108 14s 10d

The interest from endowments was larger than usual owing to the fact that we received one quarter's dividend on Consols and India Stock before the sale of these securities, and the full year's dividend on the stocks purchased.

At the last annual meeting it was decided not to hold a bazaar in 1925, and it was proposed that a special effort should be made to secure increased subscriptions in all the parishes in the county. This effort proved very successful, and the sum of £202 12s 2d was received from the home
