yesterday Mr Blythe reviewed in a one and a half hour's speech the financial position of the Saorstat.

The most unexpected point in his proposals is a tax on betting. Otherwise there was nothing very startling in his speech.

The system of double taxation is abolished. A revised scale of charges is proposed for motors, which will relieve the handicap on Fords, and increase the tax on heavy vehicles.

A Customs tariff of 2s. 6d. per ewt. is placed on oatmeal, but none on manufactured goods.

A Tariff Commission is, however, to be set up, and if the Government find themselves able to agree with the Commission's recommendations, a resolution will be submitted to the Dail, no matter at what period of the year, imposing the tariffs recommended.

Announcing that the Government could not see their way towards reducing the excise duties of beer and spirits, the Minister said that only a substantial reduction would be of any use, and this would mean of revenue of about £1,400,000.

The brewing industry was able to take care of itself.

To keep the reputation of Irish whisky right it was proposed to increase the period for which spirits must be matured from three to five years.

The duty on wine is to be increased by 100 per cent., but owing to the enormous rates of profit in the trade that should afford no excuse for increasing the price to the public.

Owing to the quantity taken out of bond recently no appreciable increase in revenue is expected this year, but next year the higher duty should yield from £150,000 to £200,000.

With regard to broadcasting he announced the fee for crystal sets at 10s. The imposition of a customs duty of 33½ per cent. on transmitting or receiving sets is proposed.

The existing ban on betting is to be removed. Bookmaking will be legal for persons who have paid £10 excise licence duty. A £20 licence duty must be paid on premises where betting is carried on. All transactions will be liable to a tax of 5 per cent. on the sum staked. The provision of the Gaming Act will remain, and it will be an offence to attempt to bet with a bookmaker outside the Free State.

The Executive Council were unable to agree to the recommendations of the Special Committee of the Dail regarding the duty on home-grown tobacco. Tobacco growing on an economic basis in the Saorstat was not feasible, and they should stop throwing good money after bad.
