SHANNON SCHEME.

Minister and Demand for Current.

Mr P. McGilligan, Minister of Industry and Commerce in the Free State, addressed a meeting of representatives of the commercial and professional community on Thursday night in the Engineers' Hall, Dawson street, Dublin, on "Electricity Distribution and the Shannon Scheme."

He said that under ordinary conditions in 1929 there would be a demand for about 75,000,000 units, and they could sell it at a price which would in every case be under the generation cost of different localities throughout the country. Recall ing that the Dublin City electricity scheme when promuted was vigorously opposed by the com-mercial magnates of the day, he said that the commercial magnates did not seem to have changed much since 1890.

Minister's Attitude.

The Town Clerk has received a letter from the Secretary to the Ministry of Industry and Commerce stating:-

I am directed by the Minister of Industry and Commerce to refer to the expression of the Joint Committee of the Limerick Harbour Board and County Borough Council contained in your letter of the 5th inst., and to state that the question of deepening of the Shannon at Limerick has been considered in detail by the Minister's engineers and by the experts, and they are in complete agreement in recommending that from the point of view of the production of power, this work should be omitted in the partial development. Consequently, in the absence of any evidence that the navigation would be willing to bear part of the cost, the Minister is not prepared to authorise the execution of the work at this stage.

DEATH OF REV. J. KENNEDY, P.P.

We regret to announce the death, which took place at the Parochial House, Clonlara, on Thursday night, of the Rev. James Kennedy, P.P., one of the best known priests in the diocese of Killaloe. The rev gentleman was born in Templederry, Nenagh, in 1861, and was ordained in 1888. He was curat; at Killenena, and subsequently at Quin, and Administrator at Newmarketon-Fergus, before being appointed to the pastoral charge of Clonlara in 1905. TRAGIC ACCIDENT AT ARDNACRUSHA.

Man Killed.

A tragic accident, which soon after resulted fatully, occurred on the Shannon Scheme rallway, at Ardnacrusha, about five o'clock yesterday morning. that Daniel Hayes, a pointsman, aged 24, and a native of Galbally, County Tipperary, was caught by waggons which dragged him some distance. His legs were severed, his right hand fractured, and he also sustained injuries to his head. The Corporation Fire Brigade Ambulance was 'phoned for, and while the poor man was being conveyed to Barrington's Hospital he died on the way.

The Inquest.

At noon to day, in Barrington's Hospital, an inquest was held by Mr J. S. MacNeice, City Coroner, and a jury, into the circumstances connected with the death of Daniel Hayes, aged 24 years, from injuries sustained while employed on the Shannon power scheme near Clonlara on

yesterday morning.
Superintendent Mooney, Killaloe, conducted the inquiry; Mr J. T. Liston, solicitor, Charleville, represented the next-of-kin; Mr J. Dodds, solicitor, Messrs Siemens-Schuckert, and Mr 3. Shannon, the Ministry of Industry and

Evidence of identification was given by James Hayes, Ballyfinogue, Kilfinane, brother of the

Dr. M. McSweeney, Doonass, medical officer-for the contractors of the Shannon scheme, stated that deceased, when he saw him after the accident, had his two legs crushed and accident, had his two legs crushed and lacerated; his left ear was severed, and he had s long scalp wound. Hayes succumbed in the ambulance while on the way to hospital. The injuries could have been caused by being run over by train, and before being removed to hospital deceased said to him that nobody was to blame, and that the waggons of the train went over him

Thomas Shattock, driver of the engine of a train at Clonbira, stated on yesterday morning he was engaged in shunting waggons from a siding on to the main line. The deceased was pointsman of the train and received the signal from him to come backwards. After coupling the waggons deceased told him to get back, and a little later he saw a lighted lamp on the line, and on leaving the footplate witness walked back and saw the deceased lying across the rails. That was about forty yards from the points, and witness did not previous to that notice anybody on the line or hear

To Mr Liston-It would be when reversing the engine deceased was struck, and rolled over.

James Barber, fireman on the engine, corroborated the evidence of last witness. He added that he knew nothing of the accident until told by the driver.

Martin Ryan, a foreman on another section of the work, stated that he was forty yards away when he saw a man, the deceased, in the centre of the line. The waggons overtook him, struck him and rolled over him. Witness ran to his assistance, and with the help of Shattock and another took him to the dressing station. He was then conscious.

The jury found that death was due to shock and haemorrhage, as the result of injuries received by being rolled over by a train.

CO. LIMERICK MOTOR FATAL ACCIDENT

Inquest.

An inquest was held in the County Infirmary, Limerick, on Thursday evening by Mr J. S. MacNeice, City Coroner, and a jury, into the circumstances connected with the death from injuries of Jeremiah Heffernan, Dromkeen, in the institution on the previous morning.

Superintendent Tobin represented the authorities, and the evidence went to show that deceased, who was 63 years of age, and a labourer, was struck by a motor car while crossing the roadway near Newpallas on Monday. The car, a two-seater, was driven by Mr P. P. Roddy, accountant, National Bank, Clonmel, who did everything possible to avoid an accident.

The medical testimony, as given by Dr. Murnane, was that deceased sustained injuries to the head and a fracture of the right ankle. Death was due to shock following the injuries received by the deceased.

The jury returned a verdict accordingly. Mr J. S. Gaffney, solicitor, appeared for Mr Roddy, and Mr Tynan, solicitor, for the next-of-kin of the deceased.
