OMNIBUS STANDS.

The question of putting into operation the by-laws recently framed for the regulation of omnibus stands in the city was again under consideration at the meeting of the Corporation Vehicles' Committee last night. As the Committee was not yet in possession of the arrangements between the Reliance and Irish Motor Omnibus Companies, it was decided to defer consideration of the matter to a further meeting.

RECENT LIMERICK MOTOR FATALITY.

The City Coroner, Mr J. S. McNeice, held an adjourned inquest on Tuesday night into the circumstances under which William Sheehan, aged six years, met his death on the 9th instant, when her was knocked down by a motor car driven by Michael O'Meara, V.S., and against whom informations were refused at the District Court in Hospital, subsequent to the tragedy.

Evidence was given by Mr O'Meara to the effect that when approaching the town of Hospital, at a place called Gotoon, three children darted across the road in front of the car, which was travelling slowly, at the rate of nine miles an hour. He immediately swerved, to avoid the children, but found that young Sheehan had been struck and knocked down. He took him to the residence of Dr. Cleary, and subsequently drove him to the County Infirmary.

The jury returned a verdict of death from injuries accidentally sustained.

CITIZENS AND RATEPAYERS' SOCIETY.

A meeting of the Citizens' and Ratepayers' Society was held at the offices, O'Connell street, on Tuesday night A letter was read from the Ministry for Local Government stating it was not yet decided when the municipal elections would take place.
