## CITY BOARD OF HEALTH.

Mr J. Reidy, B.C., presided at the City Board of Health on Thursday evening. There were also present:—Alderman Henihan, dessrs McNamara, White, and O'Callaghan, 3.C.'s, with the officials.

Contracts for the coming six months were onsidered.

For oil the Calena Company were accepted on a vote, the Irish American Oil Company endering at the same price, 11d per gallon. Tenders for tea were received from Mr E.

1. Fitt and Mr Michael Collins, and after some discussion they were ordered to be sent to the tester unaccompanied by price.

The Secretary (Mr Quilligan) said that on one occasion the Department's tester had a sample of the tea used in the Institution, and he classed it as having been up to the contract standard or maximum price.

Mr Barry (House Steward) agreed, and said they were at that time getting it at 2d less than the maximum price, and thus saved 10s per week.

Tenders for various supplies were received from Messrs E. G. Fitt, O'Connell street, and Wm. B. Smith, Patrick street.

Selection was deferred to next meeting, by which time the maximum prices would have been received from the Department.

A letter was read from the Shandon Castle Margarine Factory stating that they had been declared contractor to the Board under the combined purchasing scheme.

Mr Thomas Keane. Home Assistance Officest, wrote applying for an increase of salary

Replying to questions, the Secretary said that Mr Keane's salary worked out as follows—£153 from the City Board of Health; £34 from the Corporation, and £51 from the County Board of Health, making a total of £252. Proceeding, the Secretary explained that the notice of motion for an increase had been on the books for the previous meeting, but was adjourned to enable him (Secretary) to get full particulars as to Mr Keane's remuneration.

Ald. Henihan asked if Mr Keane had not been appointed by the old Board of Guardians.

The Secretary said Mr Keane had been a city officer some years ago, and his sphere of duties embraced the city and rural district. When the amalgamation scheme came into operation he was retained for the city. They would not find many officers who had so much work to do. Alone he had the whole city to look after. #### DEATH OF REV M. McCOY, P.P., ARDPATRICK.

The death occurred at the Parochial House, Ardpatrick, last night of the Rev Mortimer McCoy, P.P., in his seventy-fifth year, and after a rather brief illness. The deceased elergyman was a native of the parish of Kilcoleman, and was ordained nearly fifty years ago. He ministered as curate in St. Munchin's and Ballingarry, where he spent over twenty years. In 1918 he was appointed by the late Bishop Hallinan to the pastoral charge of Ardpatrick in succession to the late Rev. T. Graham, P.P. Father McCoy was a brother of the late Rev. Jas. McCoy, P.P., Bulgaden, and of the late Mr. Richard McCov who was Lord Mayor of Dublin in the early nineties.
