is Mrs McGrath, wife of Dr McGrath, Superintendent Medical Officer of Health. the work is carried on each day during the week, and a large number of repasts are supplied at the normal sum of twopence in the case of dinners, and a penny for a cup of tea with bread and butter. Contributions in money and kind are made by many friends, but the cost of running the kitchen is far in excess of the receipts, and much additional help is necessary if this charitable work is to be carried on unimpaired. And if a reminder were needed of its absolute need, and its utility, it is the severe weather through which we have passed this winter, and the boon it is to the poor to be supplied with comfortable meals under cheerless and trying circumstances atmospherically. We trust, therefore, that full financial support will be forthcoming to carry on this highy deserving cause of charity.

## THE LATE MR F. C. CLEEVE.

The funeral of the late Mr Frederick C. Cleeve, took place yesterday morning from Woodlands, Castleconnell, for St. Mary's Cathedral cemetery, where the cortege arrived at 11 o'clock.
