That is an appallng condition of affairs, and if the Health loard are content to treat the allegation ith levity, then the ratepayers should action. The money spent on his form of relief comes to the high total of 68,000 a year, and from the statement made by the Secretary to the Board at the recent neeting that sum will not be sufficient to neet the demands for the full period of the anancial year of March next. Nobody will be rash enough to suggest or imply that the members of the Board have not exercised due care in the disbursement of this money, but it is quite possible that there are leakages, and that it is being given to people who, to say the least, are not entitled to be a partial charge on the rates. At all events it is incumbent on the Board in its own interests to investigate the allegation of Mr Gilligan, for a more camaging utterance has not been made in civic administration for a very considerable time past.

THE CHURCH OF IRELAND.

The Bishop of Limerick, in St. Mary's Cathedral on Wednesday admitted to the deaconite Mr Launcelot Lucian Sullivan, B, A, of Dublin, and licentiate of Lichfield Theological College. Mr Sullivan has been licensed to the curacy of Tralee, and also as diocesan curate of Ardfert and Aghadoe. The sermon was preached by the Ven. G. E. Power, Archdeacon of Ardfert.

A GERMAN IN TROUBLE.
