## CORPORATION CLERK OF WORKS APPOINTMENT.

Relative to the proposal of Councillor J. Angley that the Corporation should have the appointment of a clerk of works in connection with the reconstruction of the road from Corbally to Patrick street, a letter was read at last night's Improvement Committee meeting from the Law Adviser pointing out that as the work was being financed out of the Road Board Fund he was of opinion that the proposal of Councillor Angley would create an impasse. He based his opinion on the fact that the works clerk should be approved by the City Surveyor, and suggested that the proper course to take was to write to the Roads Board Secretary pointing out their objection to the appointment being made by the Surveyor.

Councillor Angley proposed and Councillor Casey seconded that the Committee assert their right to appoint the clerk of works.

Alderman Donnellan moved that no action be taken, adding that they had full confidence in their Surveyor.

Mr Goodwin seconded, and the voting being abortive, the Mayor said the question could be re-opened later.

## CORK EXHIBITION IN 1932.

### Decision of Public Meeting.

### President Cosgrave Encourages Scheme.

“That this meeting approves of the holding of an Exhibition in Cork during the year 1932, if, after inquiry, it be found feasible.” This resolution, moved by the Chairman of the Harbour Board, and seconded by Mr B. M. Egan, T.D., was unanimously passed at a representative public meeting in Cork on Tuesday.

President Cosgrave, who proposed the appointment of a committee to undertake the project, said it was a very big consideration, but the great success which had attended exhibitions in other places encouraged one to hope that Cork could carry through such an undertaking successfully.

An exhibition would not alone put the people into touch with the manufacturers, but would enable the people of other countries to take advantage of the goods turned out here. The industries of Cork, the President said, were such as any nation might be proud of, the vast majority of the manufactures being exported.

The Lord Mayor (who presided) said it would be necessary to survey the position and collect the necessary data and details, after which a full report would be submitted by the Committee, when a definite decision could be arrived at.

## INFANT'S CHARRED REMAINS

### Found at Ardnacrusha.

The partially charred remains of a newly born infant were found by Sergt. Staunton concealed in an ash heap in front of a house at Blackwater, Ardnacrusha, and an inquest was held upon them by Coroner P. Culloo on Monday evening.

Following upon a post mortem examination, Dr Joseph Humphreys and Dr George Enright stated it was impossible for them to ascertain whether the child had had a separate existence, and, on their recommendation, it was directed that the lungs should be sent for pathological examination to Dublin. In the opinion of the doctors, this would reveal whether the child had ever breathed.

Pending the result of this examination, the inquest was adjourned for a fortnight.
