The most essential, he added, from the viewpoint of sugar refining, was that it had an abundant supply of fresh water, eliminating the costly process of distillation of salt or brackish This was a factor that was stressed by the representative of the firm of Messrs Fairies, and may be the one that will induce the firm to select Limerick.
