It would be well if similar drainage schemes were carried out in the County Limerick, where there is so much damage to flooded land in certain districts.

ENNIS ROAD MOTOR ACCIDENT.

Defendant Discharged.

At the City District Sessions yesterday evening, before Mr J. M. Flood, B.L., District Justice, Michael Cussen, Janesboro', was charged with the manslaughter of a boy, aged eight years, named Patrick Pratt, North Circular Road, on the 3rd December. Mr J. J. Power, State Solicitor, and

Superintendent Stack, appeared for the Attornoy-General; Mr C. S. Ebrill, solr, for next-of-kir, and Mr T. E. O'Donnell. solr, for accused.

Mr Power suid the facts of the case were that the accused was driving a motor car on the evening in question from Ennis to Limerick. and the little boy was going home from the city in company with other boys. There was no allegation that Mr Cussen was driving at an excessive speed. The whole case for the prosecution was as to whether the accused was negligent in not immediately applying the brakes, or in swerving the car, which apparently turned out to be an error of iudgment. . It appeared when the boys reached Mr O'Mara's gate, on the Ennis Road, young Pratt ran across the road. although being told not to do so by one of his companions, and was killed by the motor It was only fair that he (Mr Power) should mention that Mr Cussen was terribly distressed over the occurrence.

A little boy named Denis Fitzgerald said when the deceased was running across the road witness shouted to him to come back. Deceased continued to run across, and was knocked down by the car. The deceased gave no warning to the motorist.

Four other witnesses said the car, which was going at the rate of from 10 to 15 miles an hour, was only about four or five yards from young Pratt when he attempted to cross the road. Mr Cussen swerved immediately to the right to avoid the boy.

The defendant, examined, stated he was driving from Ennis to Limerick at a slow rate. At Belfield he saw the boy run into the car. Witness swerved to the right, but unfortunately the boy was knocked down. He had the boy immediately removed in his car to hospital.

The District Justice said the accident was unfortunate, but Mr Cussen had done everything possible to avoid it. It was, he added, very difficult for motorists to guard against accidents where boys were frequently to be seen running across the street, and parents and school teachers should instruct them as to the danger they ran in crossing roadways. He would discharge accused.

Mr O'Donnell, on behalf of the accused, expressed sympathy with the parents of the deceased.
