### PROSPECTIVE CITY RATE.

The City Treasurer has not yet completed his estimate for municipal services and administration for the ensuing financial year, but is of opinion that the rate required will be approximately at the figure for the current period 22s 8d in the \$. Within the past twelve months the Corporation has added to the expenditure by making provision for extra social services, but the greatest burden is concentrated in the maintenance of the public roads, despite the fact that a considerable area of streets has been surfaced with concrete. The prospective rate would have been higher than the figure stated by the Treasurer were it not that the impost for Poor Law services will be reduced by one and sixpence in the pound. In this respect the citizens have obtained relief from the Commissioner system of administration, as under ordinary conditions the rate would in all probability have touched 10s in the £.

## LITTLE GIRL'S DEATH FROM BURNS.

At an inquest held at Barrington's Hospital last evening, Mr Coroner MacNeice returned a verdict of accidental death, due to burns, of Christina McMahon, aged ten years, who succumbed in the institution early that morning.

## WORKER FATALLY INJURED.

### Fall from Electric Standard.

An inquest was opened in Barrington's Hospital yesterday afternoon by Mr J S. MacNeice, City Coroner, and a jury into the circumstances connected with the death of Gerard O'Halloran, aged 25, Davis street, who succumbed to injuries sustained on Tuesday by falling from an electric standard on which he was working for the Callender Cable Company in Dominick-street. ### FATAL MOTOR ACCIDENT.

A verdict of death from fracture of the base of the skull was recorded yesterday at the resumed inquest held by the City Coroner, Mr J. S MacNeice, and a jury, on Patrick Pratt, aged 8 years, who was kneeked down by a motor car on the Ennis Road on the evening of the 3rd ult. It was stated in evidence that the boy was returning from school, and ran across the road, despite the admonition of a boy named John Fitzgerald. He was caught by the car driven by Michael Cussen, who did not see him till he was underneath the vehicle. At the court criminal proceedings District Justice Flood refused informations against Cussen, and exonerated him from all blame.
