several medals and certificates for heroism in saving life, while a second man, O'Connell, was also conspicuous for bravery in saving two lives from a watery grave. The appalling occurrence of last Sunday night points to the great danger of boating at the present time, especially in the darkness of the night, on the swollen waters of the upper Shannon, with their surging, raging currents. The deepest sympathy is expressed by all classes and creeds in Limerick, and we feel assured throughout the country generally, with the relatives of the three wictims on the tragic loss of husband, father and bread-winner. It needs no words to emphasise the terrible trial which has so suddenly and swiftly come to these distressed people.

DEATH OF MR. RICHARD LEGEAR. ADARE.

We regret to record the death of Mr Richard Legear, which took place suddenly st his residence, Adare, last Sunday even-Ing. in the fiftieth year of his age. It appears that he had returned home from the golf links, where he had been playing a g. me. He was subsequently engaged playing with two of his younger children, when his wife noticed him to fall suddenly back in the armchair on which he was sitting. She immediately went to his assistance, but found life was extinct. Deceased was a man of a most kindly and courteous disposition, and was a prominent athlete and cyclist in his day. He had built up an extensive business in the motor trade, and in Adare and district his demise is greatly regretted. Deep sympathy is expressed with his widow and family in their hour of trial

At the Methodist Church last night the Rev. W. Corrigan conveyed the sympathy of those present at a lecture, with the family of the late Mr Legear,
