transmission systems at 11,000 volts, which would feed the various towns and villages. The average cost of current to consumers Mr Kennedy estimates at 3.95d per unit in 1936-7, which would fall to 3.70d. some five years later. While an average charge of 4d a unit may appear somewhat high, it is, the report points out, based on the low consumption of 41 units per head in each district in the fifth year, which figure has, as a matter of fact, already been reached by some undertakings in the County Down. The estimated cost of the scheme is £1,013,000 and it is recommended that the work should proceed by stages commencing with the Strabane district. With the supply available at this latter place it would be possible. as suggested, to arrange for supplying power to the adjoining Free State areas while the needs of other districts along the border might be met from the Shannon Thus, a linking of North and South is visualised in a very interesting manner. The Shannon Scheme has proved a great success, as the demand for current has proved. The visitor traversing the country nowadays sees everywhere lines of standards and wires which supply power to city, town, and hamlet—a wonderful revolution in everyday life compared with some years ago, especially in the rural districts, which now look bright and up to date where practically darkness had prevailed in the long and dreary winter evenings. doubt, a similarly bright picture will present itself in the North before a few years have passed, as there is little doubt there also of the success of the scheme to which we have been referring.
