DEATH OF REV. J. P. PHAIR.

We regret to record the death of the Rev. J. P. FUNERAL OF MRS LUCY C. MASSY.

Stoneville. Rathkeale.

With feelings of profound regret we here chronicle the demise of the above very much respected and popular lady, after a short and unexpected illness, at Plymouth. Massy family have had a long and honoured standing amidst the landed and peasant community of the district of Rathkeale, and are held in the highest regard and esteem The late Mrs by all classes and creeds. Massy was widow of Major Hugh Ingoldsby Massy, Essex Regiment, who died while serving in the Boer War, 1900. She was daughter of Major-General Henry Annesley Justice, Madras Staff Corps.

The remains were conveyed from England on Wednesday morning, Nov. 4th, and on arrival were immediately transferred to Rathkeale, where they lay over-night at the Protestant Church.

The funeral, which took place on Thursday morning at 11.30, was large and representative, comprising all the local gentry, and the professional and commercial community of the town and district. A very touching and pathetic incident was the removal of the cremated ashes from the church to the family vault by her eldest son. Emerging from the church door with a tiny snowwhite casket, fondly gripped between both hands, he stood on the lower step leading to the tomb, while a short funeral service was being read. This having concluded, the easket was taken in turn by Captain D. Massy and Captain I. P. Massy (brothers), who took their last farewell of the remains. Then they were finally placed on a marble slab in the interior of the vault by Major W. Massy.

The floral tributes were varied and numerous, and after being placed, extended for many yards at each side of the tomb. very handsome and expressive wreath was placed at the vault by Capt. D. Massy. It bore the inscription, "Remembrances of Stoneville," and consisted of simple shrubs from the Stoneville estate. C. Langford added a tribute from the shrubs of the Abbey lands interspersed with "Flanders poppies." Numerous other wreaths were sent by relatives and friends.

The funeral service was taken by the Rev G. C. Phair, Rector of Rathkeale; assisted by the Rev. Mr. Warner, Nantenan; and the Rev. Mr. White, Askeaton.
