Full Text of Recent Correspondence.

The Hon. Secs. of the Limerick Consumers Committee send us a copy of the following correspondence which has taken place relative to the proposed increase of electricity rates in this city :--

'Mayor's Office, Limerick. "21st November, 1931.

"DEAR SIR,—We desire to bring to the notice of your Board that, arising out of the Notices recently served on the Citizens of Limerick increasing the cost of current in this area and the indignation felt at such an action, a general meeting of the citizens who are consumers of electric current was held in the Town Hall on the 17th instant, where resolutions of protest were passed and a Committee formed for the purpose of consulting with your Board in the matter, after going into the facts of the case.

This Committee, which is representative of every class of consumer, has now met and its investigations show that Limerick is already paying what is an unduly high trate for the current consumed, and in many cases 150 per cent, higher than that which obtained when the local Power Station was under the management of the Municipality.

'The Committee request us to respectfully suggest that your Board would inform it why Limerick, which is paying a higher rate than Dublin or Cork, should be charged any The citizens rightly complain increase. against this imposition, and we may inform you that they are determined that they will not suffer these unfair charges, even to taking drastic action.
"As there will be a further meeting of

our Committee on the 26th instant for the purpose of appointing a deputation to await on your full Board, we would appreciate a reply to this communication by that date, and at the same time naming a suitable date when it would be convenient for your Board to meet this deputation.
