one factor amongst others that has a vital bearing on the situation. The subsidy of 12d. per lb on sole and insole leather production (which works out at only $8\frac{1}{2}$ per cent) proposed recently by the Government is quite useless and inadequate, and was unanimously rejected by the tanners. We have been, and still are, seeking a just subsidy or tariff, but if either of these is not forthcoming, and promptly, the boot factory project cannot materialise, and my Company may be compelled, however reluctantly, to cease manufacturing leather and factor imported leather, as some Saoistat tanners have been forced to do.

DEATH OF MR C. W. METCALFE

The citizens will regret to learn of the death of Mr Charles W. Metcalfe, who passed away at four o'clock this morning at his residence, 1 Lansdowne Terrace, Ennis At one time Mr Metcalfe was prominently identified with the commercial life of Limerick as an auditor, he having been an Associate of the London Association of Accountants, and he was an untiring worker, and a man of a most kindly and courtecus disposition. A distressing experience befell him in September, 1914, when he had a paralytic stroke while spending a holiday at Kilkee. He had been invalided ever since, and, lovingly tended by his family, he bore up with Christian fortitude and resignation. A few days ago he showed signs of failing, and the end came, as stated, this morning. The late Mr Metcalfe, who spent all his business life in Limerick, married a daughter of the late Mr Wm. Nelson, family grocer, William street. To her and the other members of the family the sympathy of a wide circle of friends will be extended in their hour of sorrow. Funeral arrangements appear in obituary notice.

DEATH OF REV. BROTHER DUGGAN.

We regret to announce the death of Rev. Brother M. P. Duggan, Superior of the Christian Schools, Limerick, which occurred last Thursday in St. John's Hospital. A native of Co. Kilkenny, he was a noted educationist, to which his whole life was devoted. He was successively Superior at Thurles, Clonnel, Waterford, and Cork, whence he went to Crosby, Liverpool, where he erected a fine College, and with marked success presided over its destinies for five years. On his recall to Ireland he was appointed to Mitchelstown, and then he became Superior at Limerick, where his zeal ard organising powers found full scope. The magnificent s hools which he was instrumental in having erected for primary education, and the improvements he made in the secondary schools, have placed Limerick Christian Schools at least on a par with any attempted by the Christian Brothers in Ireland.

Brother Duggan was brother of the Rev. J. J. Duggan, of Tramore, and nephew of Very Rev. Dr. Duggan, Prior of the Dominican Order, Limerick. The funeral, which was largely attended by clergy and laity, including the pupils, past and present, of the Christian Brothers' Schools, took place at 1 p.m. to day after Solemn Requiem Mass in St. Michael's Parish Church to Mount St. Lawrence Cemetery.

The Bishop, Most Rev. Dr. Keane, presided at the Mass, the celebrant being Rev. Fr. Purtill, C.C.; descon, Rev. Fr. Coughlan, P.P.; sub-deacon, Very Rev. Fr. Lie, St. Munchin's College, and master of ceremonies, Rev. Fr. Brassill, C.C., St. John's The chanters were—Rev. Fr. Toornhill, P.P., Raheen, and Rev. Fr. Harty, Adm., St. Michael's. There were over forty clergy in the choir.

SHANNON FISHERIES

And Power Scheme.

Deputation to Minister.

A deputa ion from the Fishery Board

consisting of Messrs J. S. MacNeice, T. E. Pegum, A. Mackey, M. Clancy, and L. Forde waited on the Minister for Lands and Fisheries, Mr P. J. Ruttledge, at Government Buildings, Dublin, yesterday and discussed with him and his technical advisers the question of the future of the Shannon fisheries as affected by the operation of the hydro-electrification scheme. The deputation placed before the Minister, who received them very courteously, the injury caused to the fisheries by reason of the wholesale destruction of fish at the tail race, Ardna-They suggested with a view crusha. to obvisting this destruction that the Lax Weir be removed, a passage cut through a nearby Quarry Hole, and a permanent grill erected at the entrance to the tuil race, so that fish would continue their course up the main stream to Parteen Villa, O'Brien's Bridge. They also suggested that a grill be placed at the intake works and measures taken to prevent the fry getting into the power canal.

The Minister, who seemed impressed with the views advanced by the deputation, said he would have the position enquired into by his engineering experts and communicate his decision to the Fishery Board at as early a date as possible.

THE ECONOMIC WAR.

President de Valera and Alternative Markets.

The debate on the £2,000,000 Emergency Fund Grant in Aid was resumed in the Dail

President de Valera, in the course of a two hours' speech defended the position taken up by the Government, and replied to criticism levelled against himself, as well as his Ministry.

So far from wanting to set up a dictatorship, he said, he believed that, in the long run, democracy was the only way in which a State could be governed.

His attitude on the oath would be the same if the oath applied to a republic.

Speaking of alternative markets, the President admitted that he saw little prospect of establishing any. But he thought it worth while making a tremendous effort to get them.

If a settlement with Britain were not arrived at within a reasonable time, the annuities, now held in a suspense account, might be utilised by the Free State Government.

The estimate was passed on division by 58 votes to 43.
