DEATH OF SIR H. NIELD, K.C.

Sir Herbert Nield, K.C., for many years Conservative M.P. for Ealing, died at his home in Bishop's Avenue, Hampstead to-day, within nine days of his seventieth birthday. Death was due to acute bronchitis.

He was a J.P. and D.L., was admitted a solicitor in 1885, and called to the Bar in 1895 ; was Recorder of York since 1917, and was prominent in Conservative life.
