The applicant's evidence was that on the 25th December last she was struck in the left shin with the pedal of a tricycle ridden by the respondent's son. After a few days the wound became sore, and she was ordered to hospital for treatment. She was unable to get a bed in the City Hospital, and the leg was still giving her trouble.

For the respondent it was contended that the accident was not caused by the tricycle, and no complaint was received from the

applicant until the lapse of ten days.

The Judge said he was not satisfied that the applicant was injured on the 25th December, and dismissed the claim.

DEATH OF THE REV. P. WOULFE, P.P.

A letter was read at the meeting of the Improvement Committee last night from the Irish Ratting Company, Dublin, stating that 80 per cent of the bait laid for the rodents that infested the Corkanree dump had beer taken. That showed that the place was over run with these pests, and to keep it clear of them the Company suggested the advisability of the Corporation entering into a contract at £56 a year.
