PRESIDENT DE VALERA IN LIMERICK.

ets Hurling Final in Motion.

President de Valera motored from Dublin Sunday and threw in the ball in the 1916 emorial Hurling final at the Gaelic thletic grounds, Ennis Road, at which mething like twelve thousand people were resent, and the day was gloriously fine. ive city bands were in attendance, and the resident, who was loudly cheered, was eceived by the Reception Committee and Guard of Honour under command of uperintendent Reynolds. He was introuced to the captains of the respective eams, viz, Ahane, holders of the Irish Press" Cup, which they won in its first year, 932, and St. Finbarrs, the respective senior hampions of Limerick and Cork. It was he intention of Mr de Valera to present he cup and gold medals to the winning eam, but the match had an unexpected esult—a draw, viz, Ahane 7-4 (25 points), St. Finbarrs 8-1 (25 points), and so the President had no ceremony to perform. During the second half of the game John Madden, St. Finbarr's goalie, sustained an njury to the shin bone and was attended by a doctor, after which he was removed in the Corporation ambulance to Barrington's Hospital. In the evening President de Valera called at the hospital on his return to Dublin and tendered personal sympathy. Yesterday evening Mr Madden was removed to Cork by train, and was seen off by the Mayor, and Mr Dore and Mr O'Dwyer on

At the Limerick Circuit Court yesterday, before Judge McElligott, K.C.,

Stephen Jeffers, 17 Brennan's-row, appealed against a decision of the District Justice at Limerick on February 5th in granting an ejectment order for overholding to Mrs Anna Lynch, Broad-street. Mr Ml. Danagher, B.L. (instructed by

Mr D. G. O'Donovan, solicitor), for the appellant, and Mr. Geo. Cullinan, B.L. (instructed by Mr A J. Blood-Smyth, solicitor),

for the respondent.

Mr Danagher said that the appellant could not be present, and asked for an adjournment of the case.

Mr Cullinan said that the case should not be adjourned, as on two occasions at District Court the appellant did not appear.

His Lordship said that he would hear the case.

Mrs Lynch stated that the house in which the appellant lived was in a ruinous condition. Up to 1930 the tenant was a man named Fitzgerald, and when he died the appellant and his mother, who were relatives of his, took possession. She was never paid any rent by them, and the Corporation had served notice on her to have the house put in proper condition. could not obey the order until the appellant left. She was quite willing to give him another room until the house would be put in order, and then he could go back again.

His Lordship affirmed the decision of the District Justice.

THE CORPORATION.

The principal business to occupy the attention of the Corporation at the monthly meeting next Thursday night is a notice of motion by Alderman Reidy, T.D., to raise by way of loan £8,000 for the purpose of installing a new gas holder and two new vertical retorts at the Gas Works. Ald. Reidy will also propose that the Local Government Minister be asked to re-insert in the City Management Bill a clause to provide a joint scheme of poor law for city and county, or in the alternative to make provision in the Bill for a contribution from Central Funds towards the relief of the poor rate. A notice of motion stands in the name of Mr Keyes, T.D., that the Council take steps to acquire suitable building sites within the borough in order to facilitate p ople anxious to avail of the provisions of the Housing Act, 1932.

FUNERAL OF MR. A. H. JOHNSTON.

The funeral of Mr Arthur Hal'am Johnston, Bank of Ireland, Clonmel, second son of Mr and Mrs R. M. Johnston, 1 Military Place, Limerick, who died in the Adelaide Hospital, Dublin, last Saturday morning, took place yesterday afternoon at 3 30 o'clock, when the remains arrived by motor hearse from the Metropolis. The demise of Mr Johnston at the early age of 27 years is deeply regretted in the city, where as an official of the Bank of Ireland for some years he was very highly esteemed, and when he left here some twelve months ago for Clonmel he carried with him the best wishes for his future welfare. A bright and promising career has been cut short, and there is deep sympathy in Limetick and Clonmel with his widow and children and with his parents in their grief. The deceased's father is an official of Ranks Limited, Limerick, and a number of the staff and the employes attended the funeral, several of the latter bearing the coffin into St. Mary's Cathedral, and again to its last resting place. The grave was lined with moss and flowers by some personal friends of the deceased.
