Serious Position.

At the meeting of the Limerick County Council to-day, at which Mr D. J. Madden presided, the Secretary reported that £75,037 of the first molety of the rate for the year ended the 31st March last had been collected, leaving £8,330 outstanding, Of the second moiety £6,581 had been collected leaving £62,199 uncollected. The Bunk overdraft stood at £80,575. Some eleven collectors had not closed their warrants, although the Council made an order that they should do so on the 1st March. It was now for the Council to proceed against the sureties.

Mr Quinlan said some of the collectors were merely mocking the Council, and having failed to discharge their duty they should be dismissed the service.

Mr Hewson When that was done on a former occasion they were reinstated.

Mr McCormack said that some of the collectors now in arrear had given the Council trouble before there was any depression in the country.

The Chairman said there was no use reiterating the depressed condition of the farmers. That exists but it is equally evident that the collectors are not as active as they might be.

Mr Hewson—The Government have withheld grants from the Council amounting to £80,000, although they have not paid the annuities to Great Britain. That is a peculiar state of affairs.

In reply to Mr Hewson, the Secretary said no reply had been received from the sureties of collectors who had been communicated with on the subject of arrears in collection.

Mr Quinlan—How much of the present rate outstanding was brought forward from last year?

The Secretary—£15,000 as being temporarily irrecoverable.

Mr Quinlaz-And I suppose it will be

£20,000 for the current year.

The Secretary said the Department had sanctioned the continuance of the Council's overdraft of £90,000, and he had applied to the Bank for a continuance of the facilities. The subsidiary bodies were looking for money, but there was none to meet their demands.

The Chairman said as the defaulting collectors' sureties had ignored the resolution of the Council some action should be taken.

The Secretary—The next step is to get

bring the city rate to a figure within the ability of the ratepayers to pay without undue hardship being imposed on them. The Corporation are striving to attain this object in reducing the impost from 31s. 10d. to 28s. 1d., with the hope of bringing it down to 25s. At a meeting of the Council on Thursday night it was stated that means would he found to give the additional relief by funding a sum of £9,000 due to the Bank on an overdraft. Should the Bank Directors consent, the reduction in the current year's rate would be equivalent to a further 1s. 4d. in the £. which would leave the figure at 26s. 9d. There is the additional hope that the impost will be cut by another 1s. 7d., leaving the omnibus city rate at 25s. 2d. This would be a total reduction of 6s. 8d., which on the valuation of the Borough represents approximately a cut of £24,000 in expenditure.
