Deputy Mulcahy—Most certainly I do, and I have frequently told the Minister so and I should be glad Mr Donnelly's intervention on this subject. Even this morning I could not go to a funeral of a friend without detectives forcing themselves into the procession.

General Mulcahy said he would raise the question as often as he could.

#### WHITSUNTIDE.

Sequel to Alleged Quarrel.

Ex-Soldier Arrested.

Patrick O'Neill, aged 60 years, a lodging house keeper, 59 Parnell street, died in the City Home and Hospital on Saturday night under rather strange circumstances.

It appears that on the 4th February last the deceased had a dispute with a one-legged ex-soldier named Timothy O'Toole in connection with a child. In the course of the quarrel O'Neill was knocked down, and while on the ground O'Toole is alleged to have bitten the thumb of the left hand. At the time O'Neill did not take any notice of the incision in the thumb until it became serious, when he consulted a doctor, who ordered him to hospital in March. spite treatment, the wound being of long standing, gangrene supervened, and operation was performed. last Wednesday his condition became and District Justice Flood critical. attended the hospital and took his deposition, O'Toole being charged with causing grievous bodily harm. The accused was remanded to the City District Sessions on Friday next

Last evening Dr M. R. Clery, County Coroner, opened an inquest into the circumstances connected with death.

Having taken evidence of identification and medical testimony, he adjourned the enquiry pending the hearing of criminal proceedings.

NEWCASTLE WEST TOWN COMMISSIONERS.

Co-option of a Member.

Minister Decides Objection.

Mr M. Culhane, Vice-Chairman, presided at a special meeting of the Newcastle West Town Commissioners which was called to consider a reply from the Minister for Local Government with regard to the objection raised at the previous monthly meeting to the votes of two members (Messrs G. McAuliffe and J. O'Mahony) arising out of a d vision on the co-option of a new member in the place of Mr Sean Brouder, resigned.

The objection was based on the ground that Mr McAuliffe was the employee of a public body, and that Mr O'Mahony was not a householder, and as a result the Vice-Chairman refused to declare the co-option of Mr P O'Connor, Churchtown, who was elected on a division, pending the Minister's

reply.

In his reply, the Minister referred the Council to Section 52 of the Commissioners Clauses Act: 1847, which stated "that all proceedings of the Commissioners or of a committee, or persons acting as Commissioners, shall be valid, not vithstanding the fact that it was afterwards discovered that there was some defect in the appointment of such Commissioners or committee, or persons acting as Commissioners, or that they or any of them were disqualified."

Mr G. McAuliffe said it was clear from the Minister's letter that the co-option was in order, and Mr P. O'Connor was according declared a new member.

HOUSING SCHEME.

A letter was read from the L.G.D. approving of the plans and specifications submitted by the Commissioners for the erection of 33 houses sunder the Working Classes Acts, and enclosing form on which application should be made for the loan of £10,200, the amount necessary to carry out the scheme.

It was decided to apkly for a loan forthwith, and to ascertain in in the Listowel Urban Council the rate of interest charged on loans raised for housing schemes in that

On the motion of Mr G. McAuliffe, seconded by Mr G. O'Mahony, it was decided that a rate be struck at the next statutory meeting to meet expenditure for the coming year.
