# IMERICK MUNICIPAL Motor Cycling Fatality Limerick Circuit Court. ELECTIONS.

#### Mr. J. McInerney Elected Fourth Alderman.

The counting of votes in the Limerick nunicipal elections was adjourned on Saturlay night to yesterday morning.

Four Aldermen have been elected-viz, Ald. D. Bourke T.D. (Fianna Fail), Ald. J. Reidy, T.D., and Ald. A. E. Goodwin (Progressives), and Ald. J. McInerney (Independent).

SIt was on the thirteenth count that Ald. McInerney was elected on Saturday night. The race for the fourth Aldermanship between Messrs. McInerney (Independent), Hickey (Fianna Fail), and the Mayor, P. F. Quinlan (Progressive) was most exciting. On the twelfth count Mr McInerney's poll was 608, Hickey 602, and Quinlan 600. From that point to the twentieth count it was a neck and neck race,

but the elimination of Hannon (Independent Labour) decided the issue in favour of At the nineteenth count McInerney. McInerney was only four short of the quota, Hickey six, and Quinlan 25. (On the distribution of Hannon's votes McInerney received 20, Hickey 4, and Quinlan 5 Ald. McInerney w s then declared elected, and the count was adjourned, leaving Hickey two short of the quota. . .

#### COUNT ENDED.

#### The New Council.

The scrutiny in connection with the city municipal elections was resumed yesterday morning by the Returning Officer, Mr P. T. Conlan, and his staff, in the Town Hall. It proceeded al! through the day, up to about 7 p.m., when it concluded in the presence of a very large and interested attendance.

The final result was the election of six Fianha Fail candidates, six Progressives, two Labour, and one Independent to the new Council, which is composed of fifteen members-four Aldermen and eleven Councillors.

The new members were elected in the following order :-

The last five candidates were elected without obtaining the quota.

It is of interest to note that fourteen of

the candidates elected received the highest number of first preferences. The only change made as a result of proportional representation was in the case of the polled 218 first preference votes, as against 176 for Mr Daly (F.F), who was ultimately elected. The last candidate was not elected until

the thirty-sixth count.

The new Council is composed of twelve old corporators and three new Thirty members of the last body sought election. VOTE OF THANKS.

Proposing a vote of thanks to the Returning Officer (Mr P. T. Conlan, Acting Town Clerk), Ald. Deputy Bourke said that the result of the election was an endorsement of the policy of the Government. Fianna Fail had done remarkably well, considering the restricted franchise. With adult suffrage they would have secured an overwhelming majority.

The Mayor, seconding, claimed the election was as much a victory for the Progres-

sives as for Fianna Fail.

# Near the City.

Draper Assistant's Sad Death.

A distressing motor cycling accident, with fatal result, occurred on the Ennis Road some short distance beyond Lansdowne bridge on Sunday evening The victim was Michael Moynihan, aged 33 years unmarried, and a drapery assistant at Messrs Cannock & Co. The deceased, it appears, had spent the day fowling at his native place, Newmarket, and on the return journey to the city he overtook a pedestrian named Daly bout a quarter of a mile at the other side of Lansdow e bridge. In trying to avoid him the machine skidded, with the result that Moyniban was flung with great violence on to the road and sustained very severe head injuries. When picked up he was unconscious and bleeding. He was removed in the Fire Station ambulance to Barrington's Hospital, where he died at 2.30 o'clock yesterday morning.

By a strange coincidence, Mr J. Reynolds, a National Bank official, a close friend of Mr Moyniban, was killed at practically the same place two years ago. On that occasion both were motor cycling into the city, after spending the day in the Ennis district, when Mr Reynolds' machine skidded, with fatal results.

# The Inquest.

Mr J. S McN sice, solr, Deputy Coroner with a jury, held an inquest at Barrington' Hospital yesterday afternoon touching the death of the deceased man.

Sergeant Lucy, Ardnacrusha, conducted the inquiry. Mr J. Kirby, Thomondgate, with whom

the deceased had been lodging, gave evidence of identifica.i a

Timothy Daly, farm labourer, Lower Meelick, stated that he left his employer's house to go for a walk on Sunday evening at about 6.20. He went in the direction of Lansdowne bridge, and as he was walking along he heard the noise of a motor cycle behind him. On looking back he saw the machine approaching at a pretty fast speed. He went in close to the left hand grass margin, but he was struck from behind and thrown on his face and hands. He was dazed for some time. In a few minutes a bus came along, and he signalled it to stop. After explaining about the accident the driver took him to Barrington's Hospital, where he was at present being treated for his injuries. He could not say how the accident occurred.

John Hynes, 'bus driver, St. John's Avenue, stated that he was driving a 'bus from Newmarket to Limerick on the night in question. While stationary at Cratloe two motor cyclists passed him, going at an ordinary speed and with good lights. One was about 50 yards before the other. He drove along the road and at a point on the Ennis side of Lansdowne Bridge a man, who he afterwards ascertained was Daly, signalled him to stop. He did so, and on alighting from the 'bus saw the deceased lying on the side of the road with a motor bicycle partly fifteenth candidate, Mr Dillon (F.F.) who on top of him. With the help of some of the passengers in the 'bus' he removed the machine. He then examined the man, whose face was covered with blood, and found that he was unconscious. The man who signalled him to stop said that he had been struck, and he (witness) brought him to hospital. Two cyclists, who were on the scene, volunteered to remain with Moynihan until he could be removed. Witness reported the accident at William Street Garda Barracks.

William Walsh, draper's assistant, working at Messrs. Cannock & Co., deposed to goin, motoring with his brother, who was driving, on the night of the accident. While driving along the Ennis road they observed four or five cyclists, who signalled them to stop. They did so, and when they got out of the car they saw a man lying on the side of the road. He was turning from side to side, but was unconscious. Witness recognised him as Michael Moynihan, and saw his motor bicycle standing near by. They took the deceased to the Franciscan Friary, and afterwards to Barrington's Hospital.

Wm. Clifford, draper's assistant; also of Cannock & Co., stated that he met the deceased by arrangement on Sunday morning. They went motor cycling to Newmarket-on-Fergus, travelling on two separate machines. They carried guns in cases, as their object was to shoot game. Deceased had his gun slung across his shoulders. They started for home about 5.30 p.m., and before doing so they lighted their lamps. They travelled at a speed of between 20 and 30 miles an hour, the deceased being about 50 yards shead of witness. Shortly after-passing a stationery 'bus at Cratloe the light on witness's machine went out. He stopped to repair it, and Moynihan continued on. While he was repairing the light the 'bus passed him, and subsequently, when he again started his motor cycle, he passed the 'ous stationary at Lansdowne Bridge. He noticed nothing wrong, and did not hear of the accident until next morning. Dr T. Morris, House Surgeon, Barring-

ton's Hospital, stated that deceased was admitted to the hospital at about 7 o'clock on Sunday night and died about 2.30 a m. He examined the deceased and found a fracture on the right side of the skull, probably involving the base. Death in his cpinion was due to shock, following fracture of the skull. Sergeant Lucey gave evidence as to

examining the scene after the accident, and finding a triangular stone near the spot with what appeared to be bloodstains. There was a mark of a skid about 16 feet in length leading to the spot where the deceased was found lying.

The jury brought in a verdict of accidental death, and expressed deep sympathy with the relatives of the deceased, in which the Coroner and Sergt. Lucey joined.

DAINSTORM IN IRELAND

Workmen's Compensation Claims. Judge McElligott, K.C., continued the

business of the Circuit Court yesterday with the hearing of workmen's compensation claims.

Martin McInerney, Shelbourne Avenue, Limerick, applied for compensation for injuries while in the employment of Messrs John Ryan & Sons, builders, Thomas street, Limerick.

- The applicant's case was that while engaged lifting stones on to a platform on the 2nd April last he strained his back, and had been discharged from hospital as incurable. He was in receipt of 27/6 a week since the date of the accident.

His Lordship said that case had already been before the Court, when Dr T. Foley was examined for the applicant, and Dr C. Molony and Dr H. Roche-Kelly for respondents. Applicant then stated he was unable to attend the Court; and his evidence was taken on commission by Mr D. Downing, B.L. The medical assessor, Dr J. Roberts; reported that when he visited the applicant he was in bed. McInerney stated he could not move, and whenever the dector touched him he screamed with pain. When Dr Roberts tried to reflex his hand very gently McInerney resisted, saying the motion burt him very much. The assessor was of opinion that the spinal column was alright, and that the applicant had grossly exaggerated his condition. Furthermore be was malingering and quite able to work.

His Lordship dismissed the application with costs and six guineas expenses. He allowed the commissioner a fee of 5 guineas with five guineas expenses,

Mr O. Moriarty, (instructed by Mr J. S. McNeice, solicitor) for the applicant, and Mr G. Cullinan (instructed by Mr D. G. O'Donovan, solicitor) for the respondents.

In the case of Christopher O'Donnell, Boherbuoy, who claimed compensation for injuries sustained while working for Jerli. Carmody, stevedore, the Judge awarded 29s 5d a week, which included war bonus. In the case of Bernard Carter, John

Square, who was injured while working for Messrs. P. Molloy and Sons, builders, an award was made of 10s Sd per week plus war bonus to the 31st October, and 2s 6d a week from the 1st November, with costs and expenses.

# COLLEGE PLAYERS.

New Production.

"The Far-Off Hills."

The College Players gained fresh laurels in their presentation of "The Far-Off Hills," by Lennox Robinson, at the Catholic Institute last night. The play is full of subtle humour, which lent itself ad:nirably to the capabilities of the players

This is the first production by the group this se son, and as was expected, proved to be a great success. Miss Nellie Dundon, the producer, is to be warmly congratulated on the selection of the caste. This important consideration gave to the production an impression of finish that largely contributed towards its general success. A very noticeable feature was the manner in which the piece centred around four lady performers, to whom much of the laurels must go. The male characters were all very good, but owing to the construction of the comedy the ladies took the most prominent part, and proved themselves fully equal to their responsibility.

In Act I. Miss Pop Typan carried off the honours by her fine impersonation of a prim young lady with a distinct inferiority complex. That she is an accomplished artiste was proved by her interpretation in the final act, when she was most convincing as a winsome and attractive personality. This young lady was really deserving of the rounds of applause which she received.

Miss Nora O'Malley was particularly fitted for her part, and sprang a great surprise in her rendition of "Susie Tynan." Since her last appearance with the College Players she has progressed both in technique and elocution, and her acting left nothing to be desired.

The remaining three female characters made their debut on the amateur stage. Of these Miss Kathleen O'Sullivan was the best. As "Ellen" she appeared quite at

home in her role, and judging by her success she should be a great asset to the Players in the future. Miss Daisy Doran as "Anna," and Miss Kitty O'Dwyer as "Dorothea," were both very good, and made the most of their roles.

They evoked repeated laughter and applause. Of the male characters, the -heaviest role 4d fell to Mr Jimmy Gould, who as ." Patrick Clancy," an almost blind old man, gave a fine display, and was most effective in pro-

viding the necessary touch-up pathos. Mr Des. Curran was really good as "Pierce Hegarty," and Mr Joe Daly as "Harold Mahony," an incurable pessimist, eyoked loud laughter and applause.

Mr Jack O'Dwyer was, as usual, very good, and gave a most effective rendering of his small role as "Dick Delany," and Mr Bob Mathews as a jlly devil-may-care "Oliver O'Shaughnessy" was convincing

and effective. Excellent musical numbers were rendered during the intervals by Miss Gaffaey (piano) and Miss O'Donnell (violin).

The play, which was admirably staged under the direction of Mr J. J. Hayes, was thoroughly enjoyed by the audience, and no one should miss seeing it during the week. The performance starts at 8 15 p.m.
