STE WATER.

At a meeting of the Public Health Committee last night a letter was read from the Department of Local Government asking to be supplied with a report from the Borough Surveyor on the proposal to send Mr P. Rockett, waste water inspector, to Dublin for a course of instruction in waste water detection.

The Borough Surveyor stated that Mr Rockett was doing excellent work, having been instrumental in reducing the consumption of water last month from 2,300,000 gallons daily to 2,000,000 gallons. That being so there was no necessity to send him to Dublin.

CORKANREE REFUSE DUMP.

Reporting to the Public Health Committee at a meeting last night, on the Corkanree refuse dump, the City Surveyor stated that while the dump was objectionable, he was unable to say what effect it had on the health of the people. It was, he stated, absolutely necessary to have a refuse depot at Corkanree, as being the most suitable place in the city. Furthermore, the refuse dump was now being used to strengthen the river bank.

No action was taken on the report.

She joined the Methodist Church of Ballingrane, and in August, 1760, emigrated to New York (in a ship from the quays of Limerick), with her husband, Paul Heck, and a number of other Palatines, under the leadership of Pnilip Embury. In October, 1766, Embury preached in his own house the first Methodist sermon in America to a congregation of five persons, of whom She took a Barbara Heck was one. prominent part in the erection of the first Methodist Church in America-in John Street, New York, where a tablet stands to commemorate her name and services in connection with the origin of American Methodism.

is to Philip Embury (a cousin of Barbara Heck), who was born in Ballingrane in 1728. It is recorded that he was received on trial as a Methodist Minister by the Rev John Wesley in 1758. In October, 1768, be dedicated the first Methodist church in, as stated already, John street, New York, where a tablet is erected to his memory. Thus, these two people from the Ballingrane Palatines were the founders of American Methodism, which is a flourishing Church to-day in that country. Another historical memento in Ballingrane church is a horn which was used by John Wesley to call the congregation to prayer whenever he visited the locality. This, it is interesting to note, was used on Tuesday just before the service opened in the Embury-Heck Memorial Church the title given to it when erected.

He also spoke of the missionary work of the Church in various countries down to the present day, and of his experiences in America and India. Concluding he said that they had met to-day to pay a tribute to the memory of the brave woman and members of her family who began work in America. They offered up thanks that here in this village as a girl Barbara Heck gave her heart to God, and they gave thanks for that Irish devotion and stability of purpose which characterised her, whole life till she passed to her reward after years of work in the Dominion of Canada.

Mrs Smith next spoke, and referred to woman's work in America and in the uttermost parts of the Earth in connection with the ministrations of the Methodist Church.
