If the Government cannot or are unwilling to play their part, then the Hospills' Trust should be approached. A grant of, say, £20,000 a year for five years would not make any appreciable drain on the income of the Trust, and would be greatly appreciated. The one essential factor is that the children must be removed from the streets, which in these days are no place for recreation purposes, in view of the fast-moving traffic which momentarily passes through them.

LIMERICK ACCIDENT

Woman's Claim For Damages Settled

Before Mr. Justice Hanna, in the High Court, a settlement was announced in an acton of Mrs. Annie Tobin, of Newenham Street, Limerick, against the Electricity
