

Mr Loughrey—We must anticipate further reductions in income for years to come.

The Secretary said that if the Board contemplated carrying out future development works, they could not be undertaken having regard to falling revenue. The Board was not just in a position to meet commitments in respect of the present extension. The fall in revenue was due chiefly to falling off in wheat and timber exports. The wheat imports decreased by 28,000 tons and timber by 18,600 tons.

Mr Loughrey—We will have to watch our finances very closely, as the port of Dublin, according to published statements, has had a record year. Everything appears to be going to Dublin.

The discussion then terminated.

The Secretary reported that since last meeting six regular traders, one coaster, and four overseas vessels entered the port.
