only a traction of it will find its way into the municipal exchequer. While we admit that the Manager was confronted with a difficult task in the preparation of his estimate, we should prefer to think of a more reasonable expenditure. The rate, as we have stated, is too high, and further exploration of the avenues that have contributed to it should have been made by the Council. Instead the members let themselves go in pæans of exultation that the impost has been kept at 25s. 9d. in the hop: that next year, or at some other time, relief will be given to the ratepayers. A closer scrutiny of the estimate would have the effect of pruning, but the Council contended itself with swallowing the whole bill, which is on the basis of gross expenditure £15,000 more than last financial year and £24,000 more on the net basis.

DEATH OF MR. J. P. LYNCH.

The death took place to-day, at his residence. Barrington street, Limerick, of Mr Joseph P. Lynch, at the age of 65 years.
