

Denis O'Sullivan, Bruff, labourer, brought a claim for compensation in respect of an injury to his hand sustained while in the employment of the Limerick County Council.

Mr. G. C. Cullinan, B.L. (instructed by Mr. Nial Gaffney, solr.), appeared for the applicant, and Mr. T. K. Liston (instructed by Mr. Roger O'Sullivan, solr.) for the respondents.

Applicant stated that while working for the County Council on the 10th April he was struck on the hand by a sledge hammer, with the result that his hand was broken and crushed. He was operated on by Dr. O'Connor in Croom, and a piece of his finger removed. He was paid compensation at the rate of 22/6 per week up to June the 27th. He was not suitable for work until the middle of July, and he was now quite satisfied to go back to work for the County Council.

For the respondents, Dr. Corboy said that he examined the applicant and found that there was a slight impairment of the grip of the left hand.

#### £25 Award.

His Lordship said that the man was entitled to £25 compensation and costs.
