### HOME ASSISTANCE.

On 25th ultimo, the latest date for which statistics are available, 1,102 persons were in receipt of home assistance in the city. For the four weeks ended on the date mentioned a total sum of £640 11s. was paid to necessitous people, representing an average weekly outlay of £160 2s. Apart from home help, some 268 persons were assisted in the City Home; 15 in the Fever Hospital; 40 in the Acute Hospital; 18 in the Tuberculosis Hospital, and 17 in extern institutions. Altogether, therefore, 1,460 individuals were assisted under Medical Charities Acts.

The mistake has arisen in consequence of the last Act cutting down the Ordinary Stock from £100 to £10, the Guaranteed from £100 to £50, and the Preference from £100 to £33, and thus, if an old holder of, say, £900 Ordinary stock or less was reduced to £90 or less, under the Order, which gave only 1 vote upon £100 or more new stock, but not 1 votes to anyone holding less than £100 new stock, they are thus deprived from voting, and it can be readily realized that the rank and file of the holders and the customers of the Railway are deprived of having any voice in any election, which is contrary to common sense and inequitable, and it is not just to allow a small number of corporate bodies to dominate the situation any longer.

A small amendment only is required to carry out the matter with justice to all concerned forthwith by an amendment adopting 1 vote to every stockholder holding collective stocks of the nature above mentioned amounting to less than £100, and one further vote for each additional £100 over £100. Maximum votes for any corporation not to exceed 50 in number, or even a lesser number, as might be thought best by the Minister.

The method of voting could also with advantage be amended by a simple method—sending such voting papers to all stockholders in the same wrapper as the accounts and notice convening the meeting, which voting paper could be signed by the voter, and owing to the amount of his stock already at the head of the voting paper with a view to earmarking the number of votes, there need not be any privacy about the matter. The ridiculous Declaraion Form to be signed and witnessed\_could be dispensed with, and multiplicity of printing matter and postage, and confusion to some voters, would thus be obviated: and, besides, the redundant matter in the Irish Railway accounts and reports could be also avoided, as in some English Railways, and thus save considerable expense, as not one per cent. of the stockholders troubles about many matters set forth in the reports, although, strange to say, such reports are sent to, and can be considered and voted upon by every stockholder even though he may have only £1 in stock, whereas in the more serious matter of the election of Directors to control and manage the Company, thousands of such stockholders are denied purely by accident or oversight, I believe, any voice in such matters, which ought, in my opinion, to be amended by Act or Order before the next election.
