CITY DISTRICT COURT

Licensing Laws

Publicans Convicted

Mr. J. M. Flood, B.L., District Justice, adjudicated at the City District Court yesterday.

Supt. Meehan prosecuted Ml. Ringrose, Lock Quay, for a breach of the licensing laws on Good Friday.

Mr. D. G. O'Donovan, solr., appeared for defendant.

Guard White gave evidence to the effect that he was passing down a lane at the rere of defendant's premises on the day in question, when the back door opened and a man came out. He called this man and took him back into the publichouse. Inside he found two men and the assistant. Mr. Ringrose told him that the men were good customers of his, and he could not refuse to let them in.

Mr. Ringrose, in evidence, said that on the day in question his assistant was putting out refuse when these men came along. One of them said he had been working in the dock all day, and as they were good customers of his, he could not refuse them a drink. When the Guard came in the men had been only a few minutes on the premises.

Supt. Meehan stated that there were two previous convictions against he defendant, the last being in 1934.

The Justice, in fining defendant £1, warned him as to his future conduct.

The men found on the premises were ned 2s. 6d. each.

BOOKMAKER'S LICENCE.

Mr. E. Leahy, solr., applied for a rerenewal of bookmaker's licence on behalf of Ml. Quinlan, Parnell Street, Limerick.

Supt. Meehan opposed the application and said that Quinlan had previously been fined approximately £2,000 for evading the Inland Revenue tax while practising as a bookmaker. This was subsequently mitigated to £125.

Mr. Leahhy said that Quinlan had been unlucky, and that he had been imprisoned for failure to pay the fine. He considered that his client was entitled to a fresh start.

Mr. Murphy, an official of the Inland Revenue Department, in reply to the Justice, said he had been sent down from Dublin especially to oppose the application.

Justice—I am not going to take upon myself the responsibility of granting a licence. At any rate there are too many bookmakers in Limerick.

NEGLIGENT DRIVING.

Supt. Meehan prosecuted Christopher O'Connell, 98 O'Connell Street, for negligent driving in William Street, on Saturday, 7th May.

Mrs. Wallace, Castleconnell, said she was driving across William Street on the day in question, and was turning into Gerald Griffin Street. The defendant came along, driving a motor car.

Impressive Tribute

Cottage Repairs

Ahane and Costleconnell Branch of the Irish Labour Party forwarded a resolution calling on the Board to speed up the repairs of cottages during the summer months, "as some of them were in an appalling condition for the want of repairs. There were plenty of contractors willing to carry out the work but Mr. Dee, the engineer, states he cannot get them without instructions from the Board."

Mr. Mackey said that there were contractors in his area who were idle.

REPAIRING COTTAGES ALL OVER THE COUNTRY.

Secretary—They are repairing cottages all over the country at the present time. as far as I am aware.

Mr Mackey said that the present would be a good time to have the repairs carried out.

Secretary—A sum of £7,000 has been set by for repairs. You have already contracts let and you must pay them. We only get £7,000 from the County Council in instalments. We get half on 1st April and we don't get the remaining half until 1st October. If you expend £7,000 in the first half year you won't have the money. You have only got £3,5000.

Mr. Quaid said that it would be very serious if actions were taken by people against the Board.

Mr. Mackey said that very little of the money was spent in his parish.

Secretary—I would not say it has been spent, but the contracts have been let.

Mr. Mackey—I know, but not in our parish.
