Transfer of Rev. Br. O'Neill

Loss to Limerick

Rev. Br. E. B. O'Neill, who has been Superior of the Christian Brothers' Schols, Limerick, for the past six years, has received notification of his transfer and will shortly leave to take up duty in another centre.

Brother O'Neill has been identified with secondary education for almost 30 years, during the course of which he has served teaching periods in Dublin, ab. Synge Street, Westland Row, and O'Connell Street Schools. His teaching abilities and administrative capacity was early recognised, and he received his first appointment as Superior in Athy. He was subsequently transferred to Naas and at other periods was attached to Waterpark College, Waterford, and North Monastery, Cork.

MANY IMPROVEMENTS.

During his time in Limerick Brother O'Neill was responsible for the erection of two large ball courts in the schools, and carried out many improvements and renovations. It was a happy honour that during his Superiorship Limerick Christian Schools for the first time won the Honan Scholarship this year—a coveted Munster Blue Riband. The record of the schools in departmental and other examinations this year broke all previous standards, and was a further tribute to his able supervision. While he was primarily concerned with the scholastic attainments of the 2400 pupils under his care, Brother O'Neill displayed a broad-minded toleration for all games, and was keenly interested in all pastimes that helped to build up the physique of his students.

Brother O'Neill's transfer will be heard of with regret by his numerous friends in the city, and general good wishes will be extended to him for a continuance of the good work to which he has devoted his life.

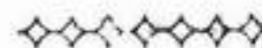

CITY MANAGERSHIP.

The Department of Local Government cannot be accused of any delay—due or undue—in filling the position of City Manager and Town Clerk. Applications must be in the hands of the Local Appointments Commissioners by the 6th proximo, and candidates must not be less than thirty years of age and possess high qualifications. Not only is he required to be well educated, but of high administrative capacity, and, inter alia, be skilled in the delicate art of the conduct of negotiation. In a sentence, the incoming Manager must be a jolly good fellow, not in the accepted sense, but administratively. The job carries a tidy salary, £800 a year initially, which is an attraction. Then there are increments, holidays and social functions thrown in, to take the edge off the boredom associated with Council meetings.



BARRINGTON'S PIER.
